Sir,  
With due respect and producing herewith the arrested accused person namely Triloki Sharma (45 hrs) S/O late Kapil Sharma of Daudpur, Bangra, PS- Daudpur, Dist.- Chhapra, Bihar under arrest and the following articles under seizure :-

1. One truck displaying number plate JH/09/AX/4708 loaded with following articles.  
(i) 710 (Seven hundred ten) numbers of paper made cartoon, each cartoon containing 12 bottles of " ROYAL MENSION BLENDED WHISKY" i.e. total 8,520 (Eight Thousand five hundred twenty bottles) and each bottle containing 750 ml i.e. total 6,390 (Six thousand three hundred ninety) litres of liquor, Blended & Bottled by NORTH EAST BEVERAGES, Hollongi NH-415, Dist.- Papumpare, Arunachal Pradesh (INDIA) and for sale in Arunachal Pradesh only.

I SI Goutam Mallik of NJP PS, SPC do hereby lodge this complaint against the above noted arrested accused person that today i.e. on 17.03.22 at about 17.25 hrs I received a secret source information that one truck displaying number plate JH/09/AX/4708 is coming from Arunachal Pradesh side and proceeded towards Bihar which is loaded with huge quantity of illegal I/D liquor. Accordingly, I informed the fact to the Officer-In-Charge, New Jalpaiguri PS and diarised the fact in General diary vide NJP PS GDE No 766 dated 17.03.22 and as per his kind direction myself along with ASI Khagen Barman, ASI Sajal Das, C/1053 Paresh Rava, HG/794 Ranjit Roy VP/08 Laxman Barman, VP/13 Jamirul Islam, CV/116 Rohit Mahato, CV/306 Biswajit Roy and CV/824 Niru Yadav and others all of NJP PS left for Jatiakali More under PS- NJP, Dist.- Jalpaiguri to verify the veracity of the information in hand vide NJP PS GDE No 767 dated 17.03.22 & MCC No 1025/22 dated 17.03.22. Under this circumstance any search warrant or authorization cannot be obtained without affording opportunity for the concealment of evidence or facility for the escape of the offender. In the mean time, I called two independent witnesses namely (i) Soumya Bikash @ Bubai Ghosh S/O late Jyoti Prakash @ Mantu Ghosh of Purba Dhantala, PS- NJP, Dist.- Jalpaiguri and (ii) Sukamal Sengupta S/O late Subir Sengupta of Shaktigarh Road No-3, PS- NJP, Dist.- Jalpaiguri and informed them about the information in hand and requested them to remain present with us as witness during the search and seizure if necessary and in which they agreed. At 17.55 hrs we arrived at Jatiakali More under PS- NJP, Dist.- Jalpaiguri and started to Naka Checking at Jatiakali More. At 18.35 hrs we noticed that the said vehicle is coming from Jalpaiguri side in a high speed but we police party managed to detain the said vehicle at Jatiakali More under PS- NJP, Dist.- Jalpaiguri and found one person inside the drivers cabin of the said vehicle. On being asked he disclosed his identity as Triloki Sharma (45 hrs) S/O late Kapil Sharma of Daudpur, Bangra, PS- Daudpur, Dist.- Chhapra, Bihar. During interrogation the said person disclosed that the vehicle is loaded with bricks but finally he disclosed that the vehicle loaded with I/D liquor of Arunachal Pradesh. Subsequently, we searched the vehicle and found huge numbers of paper made cartoon containing I/D liquor of Arunachal Pradesh loaded in a artificial chamber of the said vehicle.
