Sir,

In producing herewith five (04) arrested accused persons namely (i) Tapash Dhar (32), S/O- Lt Ajit Dhar of Bhujipani, P.O+ PS Bagdogra, Dist darjeeling (ii) Sanjit Mandal (26), S/O- Lt Bajyanath Mandal of Goshapur Natunpara, PO+PS Bagdogra, Dist Darjeeling (iii) Sanjit Biswas (32) S/O- Ashok Biswas of Khudirampally, PO+PS Bagdogra, Dist Darjeeling (iv) Arun Halder (22), S/O - Lt Buddhi Halder of Purbamaja bari, PO- Ghigumali, PS Bhaktinagar, Dist Jalpaiguri (not verified) arrested u/s- 41 Cr.P.C along with following seized articles viz:

- (1) One iron made sword measuring 33 inch (approx) including butt from the possession of Tapash Dhar which was kept concealed on his back side.
- (2) One iron made sword measuring 20 inch (approx) including wooden butt from the possession of Sanjit Mandal which was kept concealed on his back side.
- (3) One iron made sword measuring 22 inch (approx) including wooden butt from the possession of Sanjit Biswas which was kept concealed on his back side.
- (4) One iron made 'Kukri' measuring 12 inch (approx) from the possession of Arun Halder which was kept on his right hand,
- (5) One car (Chevrolet) Black & White in Colour bearing Registration No- WB 74 U 0477.
- (6) One Iron rod measuring 20 Inch and one Iron made Katari measuring 33 Inch found inside the rear seat of the car.

I, PSI Rantu Halder S/O- Manoranjan Halder of Matigara PS, Siliguri Police Commissionerate do hereby lodge this complaint against the above noted accused persons namely i) Tapash Dhar, ii) Sanjit Mandal, iii) Sanjit Biswas, and iv) Arun Halder, and two others namely (v) Md. Samrul, (vi) Md. Ashradul, on the effect that today on 23.03.2022 at 01.15 hrs received a source information that 06 youths have assembled near NBU gate No 1 with a Black & White car with a view to commit dacoity in a night super Bus. The fact was diarized in GD vide Matigara PS GDE No-1414, dated 23.03.2022. Subsequently, after sharing the information with my superiors and as per their direction, I along with ASI- Tapan Das, C/986 Rajib Sarkar C/1008 Kanak Roy, C/1035 Santosh Rabidas, CV/387 Sukumar Barman and CV/155 Sukumar Das left for the place to work out the information. At about 01.35 hrs after reaching NBU gate No 1 under PS- Matigara I met my source and being pointed by my reliable source approached towards six persons standing there with a black and white colour car. At that time seeing the Police party approaching towards them they started fled away from the spot driving the car but, however we managed to apprehend them with the car but two persons managed to flee away from the rear seat of the car by taking the advantage of darkness. Above noted Tapash Dhar was found driving the above noted car and above noted ii) Sanjit Mandal, iii) Sanjit Biswas, and iv) Arun Halder, were found inside the above note car. On interrogation the accused persons admitted that they had assembled there to commit dacoity in a Night Super Bus.
