On collecting information regarding the matter , it was found that one Seema Agarwal , Advocate in Siliguri Court solemnized married with one Faij Ahamed who is also advocate in Siliguri court . One marriage photograph of both of them gone viral with commenting "Yeh advocate seema Agarwal, Shantiniketan, Puanjabi para ki hai, agey sayad mujhe kuch nahi batana parega. Ab bhi yedi hum sochte rehenge to agey kya hoga pata nahi" .


Further I like to note that no mobile number or details could be found regarding this post till now. But the post and comments likely to cause, fear or alarm to the public/ community or to any section of the public whereby any person may be induced to commit an offence and may disturb the public tranquillity. Moreover the post along with the comment gives provocation to the community in both side that may convert into a disturbance or offence from the either side.

Therefore, I am submitting this complaint against the person who posted the photo along with the comment which gone viral and request you that a specific case may kindly be initiated and arrange for its investigation under proper section of law.


