Sir,

In producing herewith four (04) arrested accused persons namely 1. Md Saker Hossain 20yrs s/o Md Dhandal R/o Valkujote Munshibari Ps, Phansidewa Dist. Darjeeling 2. Md Gulab Uddin 33yrs s/o Late Md Jumaruddin R/o Kinajote Lichupakri Ps, Phansidewa Dist. Darjeeling 3. Tapash Das 22yrs s/o Jagdish Das R/o Hatia Danga Kankata More PS, Bhaktinagar Dist, Jalpaiguri 4. Md Rajjak 22yrs s/o Md Afat R/o Valkujote Munshibari Ps, Phansidewa Dist. Darjeeling along with seized articles viz

1. One "Iron rod" having approx length 04 fit from the possession of accused Tapash Das
2. One iron made "Sword" having length approx 20 inches including butt from the possession of accused Md Rajjak
3. One iron made "Khurki" having length approx 16 inches from the possession of accused Md Saker Hossain
4. One iron made "Knife" measuring approx 8 inches and one nylon made long rope from the possession of accused Md Gulab Uddin
5. One electronic Torch light, gunny bag, three empty bottle of Himalayan Gold 60up Country Sprit from the PO.

I ASI (UB) Janirul Islam of Bagdogra PS, SPC do hereby lodge a written complaint against the above noted arrested accused persons to the effect that on 23.03.22 at 22-15 hrs received a reliable source information that 09/10 miscreants armed with deadly weapons were assembled in a dark place of Fairanjote back side of Fulkali Mandir under Bagdogra Ps, with a view to commit dacoity. Accordingly without waste any time, I informed the matter to you and diarized the matter vide Bagdogra PS GDE No.1470 dtd. 23.03.22 and as per your kind instruction myself along with, ASI Dharendra Nath Mandal, C/410 Montosh Singh, CV-389 Janak Singh CV-386 Kishor Halder CV-375 Jogesh Barman, VP-01 Anselam Kujur VP-02 Pradip Roy left from PS, for Fairanjote Ful kali Mandir area to verify the veracity of the information and to work upon it. We reached near the spot as confirmed by the source at about 22.40 hrs and stopped the vehicle in a considerable distance from the Fulkali Mandir and we started walking towards the Fairanjote village of Fulkali Mandir and we reached in front of Fulkali Mandir and heard that back side of Ful Kali Mandir some persons gossiping there. We started approaching towards them slowly ambushing ourselves in the darkness and found that a group approx 09/10 persons were assemble and whispering each and others. But unfortunately one of the people among the gang seen the police team and tried to run away from the spot. Somehow, after a hot chase we could be able to apprehend the 04 (four) persons noted above and the others 05/06 persons were managed to flee away from the spot. On interrogation they disclosed their identity as mentioned above and they also admitted that they along with their other associates were assembled there with a view to commit dacoity after making full preparation in the adjacent area village of Fairanjote under Bagdogra PS. Thereafter all the apprehended persons were searched and due to late night could not found any independent witness to remain present at the time of search and seizure. During individual search, the above noted deadly weapons were recovered from their possession and seized the same under proper seizure list duly sign by them also arrested them u/s 41 Cr.P.C to maintain their decency issued them Memo of arrest and informed their ground of arrest. The seizure and arrest was made in between 22.55 hrs to 23.30 hrs

So I pray before you that a specific case may kindly be started against the above noted four (four) arrested accused persons and 05/06 others and arranged for its investigation.
