This is to inform you that my brother namely Swapan Halder being resident of Ramkrishna Pally having contact no. 8116468960, 9883052880 have come to my residence & after over an ~~arg~~ argument with-regard to disagreement over sharing the possible share of my inherited property had assaulted me & my 83 years old husband to the extent of strangling me & ~~making~~ with a utmost motive of intention to murder me for ~~my~~ claiming my share of my inherited property. He not only limited the assault to me but also ^{over} ~~over~~ my aged & ailing husband. He was eventually accompanied with his ^{own} ~~own~~ ^{knife} ~~to~~ stab me & my husband.

After causing an hue cry in the society people gathered & seeing gathering of people he ran away & had fled from the place of occurrence (my residence). It is much pertinent to mention that his arrival ~~over~~ to my residence was a matter of trespass ~~over~~ as he jumped over the fence of my residence.
