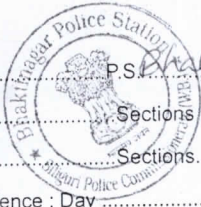

However the said Arindam choudhury was reluctant & started ignoring my calls & messages.

Yesterday, when I called, he attended my call & started verbally abusing me & my family, threatened me of dire consequences if I enter Planet Mall ever again.

That when I reached Planet Mall, in the evening at around 8 pm, to meet my brother, the said Arindam choudhury, brutally attacked me in intoxicated condition with fist & blows, thereby injuring me grievously, which has duly been recorded ~~at~~ by CCTV of that area.
