In producing here with the arrested accused person namely Sunil Kumar Sharma (29) s/o Tripit Narayan Sharma of Lenin Colony, Nera Jishu Ashram, P.S Matigara, Dist. Darjeeling along with following seized articles as per proper seizure list:

- 1] Thirty (30) Packets of Paper Cartoons each containing 12 Bottles of ROYALSON WHISKY, Blended and Bottled by KALA AMB DISTILLERY AN BREWERY PVT LTD, 9th Mile Stone, Swarghat Road, Village Bhangla, Tehsil Nalagarh, Dist. Solan (HP) each bottle containing 750 ml. [Total 270 Litres]
- 2] Fourty Four (44) Packets of Paper Cartoons each containing 24 Bottles of ROYALSON WHISKY, Blended and Bottled by KALA AMB DISTILLERY AN BREWERY PVT LTD, 9th Mile Stone, Swarghat Road, Village Bhangla, Tehsil Nalagarh, Dist. Solan (HP) each bottle containing 375 ml. [Total 396 Litres]
- 3] One White Colour Container Truck 407, bearing Registration No. WB-19F-6721 and Chasis No. MAT455052D8D11010 of Tata Motors Pvt Ltd.

I, SI Sk. Tamzid Ali of Bhaktinagar PS under Siliguri Police Commissionerate do hereby lodged this written complaint to the effect that on 24.03.2022 at around 19.25 Hrs received a source information that one White Colour Truck Container bearing Registration Number WB-19F- 6721 suspected to be stolen and loaded with huge quantity of Foreign Liquor has parked at Kholachand Fapri near Loknath Temple and is about to move from there for transporting the same in Bihar. If acted immediately they may be apprehended red handed. Accordingly I, informed the matter to you and noted in GDE for reference vide Bhaktinagar PS GDE No. 1652, Date. 24.03.2022. As per kind order of I/C Bhaktinagar PS I along with PSI Sailesh Subba, ASI Dipak Karmakar, C/374 Debraj Biswas, C/762 Mujibul Rahaman all of Bhaktinagar PS left to work out the information. At around 19.35 Hrs I reached at Kholachand Fapri and as shown and identified by the source detained one (Vehicle) Truck Container bearing Reg. No. WB-19F- 6721 which was about to move from that place. After seeing the Police vehicle the driver of the said Vehicle tried to jump and fled away from the truck but the but we could manage to apprehend him. On being asked the apprehended accused person disclosed his name and address as Sunil Kumar Sharma (29) s/o Tripit Narayan Sharma of Lenin Colony, Nera Jishu Ashram, P.S Matigara, Dist. Darjeeling. Such activity of the driver leads to a suspicion and arose strong reason to believe that the said vehicle might have stolen from some where or it may contain illegal foreign liquor. Further I called two disinterest witnesses namely 1] Manoj Yadav (34) s/o Janki Yadav of Kharat, PS Borochathi, Dist. Gaya, A/P Kholachand Fapri, PS Bhaktinagar Dist. Jalpaiguri and 2] Sunil Yadav of Sukdev Yadav of Kharat, PS Borochathi, Dist. Gaya, A/P Kholachand Fapri, PS Bhaktinagar Dist. Jalpaiguri. On the grounds of suspicion I ordered him to open the door of the container of the Vehicle in presence of two witnesses to verify the same. Accordingly the driver opened the door of the container and found above noted seized liquor loaded inside the container. On enquiry he stated that he along with his other associates has procured the above noted seized liquor from Arunachal Pradesh which was supposed to be transport in Bihar for his wrongful means. He also stated that he along with his other associates are engaged in this illegal act of transferring liquor to Bihar after procuring illegally from Arunachal Pradesh. On demand of Challan/valid documents in respect of the loaded liquor and the detained vehicle the apprehended person failed to produce the same before Police team.

Under the above circumstances there is strong reason to believe that the loaded liquor along with the detained Vehicle might have been stolen from somewhere by the apprehended accused person along with his associates and were engaged to transport for the purpose of disposal of the same for their wrongful gain. Accordingly, I prepared label and seizure list of the above noted articles in presence of wrongful sign by the accused as well as witnesses and arrested the accused person namely Sunil Kumar Sharma (29) s/o Tripit Narayan Sharma of Lenin Colony, Near Jishu Ashram, P.S Matigara, Dist. Darjeeling u/s 41 Cr.P.C after appraising him the ground of arrest. [The seizure was made in between 20.05 Hrs to 20.50 Hrs.]

I, therefore pray before your kind honour that a specific case may kindly be registered against the accused person namely Sunil Kumar Sharma (29) s/o Tripit Narayan Sharma of Lenin Colony, Near Jishu Ashram, P.S Matigara, Dist. Darjeeling and other involved accused persons under proper section of law and arrange for its investigation.
