Sir,

In producing herewith one arrested person who disclosed his identities namely Sanjay Hela @ Pathorki (23 yrs) S/O Late Dhoni Hela of Rana Busty Busty, Ward No. 18, PS- Siliguri, Dist- Darjeeling along with the seized articles per seizure list;

1. One improvised one shutter iron made fire arms measuring approx 11.10 inches approx from barrel to butt having striking pin, hammer and trigger,
2. One ammunition engraved OK 06 7Z unreadable on its percussion cap (found loaded in SI No.1 seized exclusively from possession of accused Sanjay Hela @ Pathorki.

I Uday Chakraborty of Siliguri Police Station, Siliguri Police Commissionerate do hereby lodge this complaint against Sanjay Hela @ Pathorki (23 yrs) S/O Late Dhoni Hela of Rana Busty Busty, Ward No. 18, PS- Siliguri, Dist- Darjeeling that on 24.03.22 around 22.15 hrs, received a secret source information that one veteran criminal namely Sanjay Hela @ Pathorki of Rana Busty area is roaming at Bagrakot Bus stand area under Siliguri PS with an ulterior motive and is in possession of firearm. Dairsed the mater vide Siliguri PS GD Entry No. 1739 dated 24.03.22. As per your kind instruction of I/C Siliguri PS, I along with ASI Subir Sen, ASI Dhruva Misra, ASI Siben Sarkar, CV/622 Ramanath Barman, CV/283 Prosenjit Dey all Siliguri PS rushed to the place at Bagrakot Bus Stand area to verify the veracity of this information vide Siliguri PS G.D.E no. 1740 dated 24.03.22. On way I picked up two disinterested witnesses namely (i) Surajit Banerjee (37 yrs) @ Boro Bhim S/O Late Atul Banerjee of Subhashpally, Lichu Bagar, Ward No. 18, PS- Siliguri, Dist- Darjeeling and (ii) Ratan Das (33 yrs) S/O Sri Tarun Das of do, duly informing them about the information in hand. At 22.35 hrs we reached at nearby Bagrakot Bus Stand and as per description of the wearing apparels supplied by the source, we found that the above noted person is moving suspiciously at Bagrakot Bus Stand area. On seeing the police party he tried to escape from the place. But we apprehended the above noted person namely Sanjay Hela @ Pathorki. On being asked, the apprehended person disclosed his identity as noted above. On further interrogation he admitted that he was in the Bagrakot Bus stand with an ulterior motive. Accordingly, as per information and following all necessary procedures of search of the police person by the witnesses, search of the apprehended person Sanjay Hela @ Pathorki was made. After searching we found that one improvised one shutter iron made fire arms measuring approx 11.10 inches approx from barrel to butt having striking pin, hammer and trigger loaded with 01 (one) ammunition engraved OK 06 7Z unreadable on its percussion cap was recovered from his exclusively possession, which was kept concealed under the cotton half pant on the left side of the above noted accused person's waist. The ammunitions were unloaded from the firearms as per practical experience. On being asked about the possession of the firearms and ammunition, the apprehended Sanjay Hela @ Pathorki made incoherent statements and failed to produce any valid documents in support of said seized Firearms. As there is every reason to believe that the firearms and ammunitions recovered has been procured dishonestly by the apprehended Sanjay Hela @ Pathorki for his ulterior motive, seized and labelled the firearms and ammunition duly taking its measurements and details in presence of the witnesses duly signed by them and

acknowledge by the apprehended person and arrested him following all formalities. The seizure and label was made in-between 22.40 hrs and 23.40 hrs. On being further asked the arrested accused person admitted that he was present at Bagrakot Bus Stand being armed with Fire Arms with an ulterior motive.

Under the above circumstances, I pray that a specific case under Arms Act may kindly be started against the arrested Sanjay Hela @ Pathorki (23 yrs) S/O Late Dhoni Hela of Rana Busty Busty, Ward No. 18, PS- Siliguri, Dist- Darjeeling and arrange for its investigation.
