I ASI. Canute Lepcha of Naxalbari PS Dist. Darjeeling this to inform you that as per re-endorse I received P.M report in c/w Naxalbari PS U/D Case No. 16/2021 Dtd. 24.03.2021 in which Dr. Dibyakar Chhetri Demonstrator, Dept. of Forensic Medicine, North Bengal Medical Collage & Hospital opined that "Death was due to the effects of above mentioned head injuries, ante-mortem in nature". The fact is that on 24.03.2021 received a written information from Anup Kr. Ghosh Bhowmick of Bijaynagar Tea Estate PS- Naxalbari, Dist- Darjeeling to the effect that on 23.03.2021 one Atish Lohar (M/28) S/O Sitaram Lohar of Bijaynagar Tea Estate PS- Naxalbari, Dist- Darjeeling had got bike accident and was admitted to said hospital on 23.03.2021 and expired, on the basis of said written information Naxalbari PS U/D Case No. 16/21 Dtd. 24.03.2021 was started and inquest was turn up by SI. Mitangshu Sekhar Sharma as per endorsement and in inquest report SI. Mithanshu Sekhar Sharma noted that on 23.03.2021 at about 08:30 PM deceased Atish Lohar along his other 03(three) friends were returning their home from a marriage party by Motor Cycle that faced an RTA at New Chamta Tea Garden, PS- Matigara Dist- Darjeeling.

Hence, a case under proper section of law may kindly be started and arranged for its investigation.
