DEAR SIR,

I the undersigned would like to inform you that I am the legally married wife of one Samar Saha resident of Rath khola ward no 22 of S.M.C. Near Ganada Sundari Library and our marriage was solemnized according to hindu rites and customes on 28th Nov 2004 at my paternal house.

After the said marriage we started to live together as husband and wife and out of the said wedlock I gave birth of a male child namely Rishi Saha on 4.10.2005 at North Bengal Medical College & Hospital . After few days of my new born child I gradually see some changes of my husband and with the influence of alcohol he started to assault me with fist and blows and he always asked me to give him money from my paternal house.

I would like to further inform you that I used to grab those pains and sorrows for a better future and by grabing those sorrows and pains I regularly used to tolerate those things after that one female child was born on 4.10.2012 namely Rashi Saha at Matri Sadhan Hospital .

I would like to further inform you that after passing of few days my husband used to pressurize me for bringing lots of money and whenever I asked for the reason he used to assault me even my child for no reason and after that I came to know that my husband is engaged in gambling and it is now a regular phenomena to grab money from me.

I would like to further inform you that the torture of my husband gradually increased day by day and he started to assault me regularly and also upon my both children .Finding no other alternative I move back to my paternal house for betterment of my child's future.

I would like to further inform you that on 20.03.2022 at about 7.00 P.M. When I was at my paternal home my husband suddenly came to my paternal house

with the influence of alcohol and threatened me to gave forty thousand rupees and when I asked him for the reason he started to assault me by fist and blows and after that he pressed my neck with an intention to kill me and in that mean time my minor child after seeing the said incident came there to save me and at the same time my husband then suddenly grab my minor child with his hand and he also started to assault my minor son with an intention to kill my minor son by pressing his neck, thereafter I started to shout loudly by seeing those horrible circumstance I shout for help and after hearing my shout my neighbours, family members rushed and came to my place and save me and my minor son from the grip of my husband, which was deeply mark black with the finger of my husband and in the meantime my husband fled away from my place.

Thereafter i.e. on 21.03.2022 when I was going to hospital for visiting my child my husband suddenly came in front of me and threatened me that if I will not give him money he will kill both my minor son and daughter. And due to such threatening I request to the concerned doctors to discharge my son and the concerned doctor allow my submissions and discharge my minor son.

Thereafter on today my husband is constantly threatening me that he will come to my paternal house at late night with an intention to harm my child and me.

Thereafter it is further request to you to kindly investigate the matter and do needful for the end of justice.
