**Sub: Complaint regarding misbehaviour with maintenance staff**

On 24.03.2022 around 10:15 AM the maintenance team of Bagdogra Electric Office was attending breakdown related maintenance work at Howdi Jote, Bagdogra, when one person, named RAJESH BASNET, S/O LT. SURJA BHADUR BASNET of Howdi Jote, Bagdogra interrupted the work and created disturbance with the staffs. The person first heckled with SAMA SINGHA (maintenance staff) and later when RAJA BARMAN (maintenance staff) tried to calm him down, the person also misbehaved with him. Other pending maintenance work also got delayed due to this turmoil. This kind of misbehaviour towards maintenance staff of electric department is really disheartening and strict action should be taken against it.

As this person has tried to stop government work by manhandling the maintenance staffs, you are requested to take necessary action and kindly treat this as F.I.R.
