In producing herewith one arrested accused person namely Karan Chouhan, (33) s/o Narayan Chouhan of Majlishpur PS, Goalpukur Dist, Uttar Dinajpur (Driver of Vehicle No. WB-73-E-0279) under proper Memo of Arrest along with seized articles and the copy of seizure list viz.

- 1) One Truck having Registration No. WB-73-E-0279 .
- 2) 23 (twenty three) numbers of Bullocks in different colour and sized which carrying in the Vehicle bearing No. WB-73-E-0279.
- 3) One mobile phone styled as VIVO, IMEI No. 865207036606676 & 865207036606668.


I ASI Dharendra Nath Mandal of Bagdogra P.S, Siliguri Police Commissionerate do hereby lodge this written complaint against above noted arrested accused person namely Karan Chouhan, (33) s/o Narayan Chouhan of Majlishpur PS, Goalpukur Dist, Uttar Dinajpur to the effect that on 25.03.22 at about 00-05 hrs, I received a secret source information that lots of cows are being loaded on a truck for sale illegally at Halal busty near river bank under Bagdogra PS . Accordingly, I share the information with O/C Bagdogra P.S and diarized the fact vide Bagdogra P.S GDE No. 1532 dated 25.03.22. Then as per direction of O/C P.S, Myself along with ASI Jakirul Islam C/410 Montosh Singh, CV/389 Janak Singha, CV-386 Kishor Ranjan Howlader, VP-02 Pradip Roy , VP-01 Anselam kujur left for Kestopur area to verify the veracity of information vide Bagdogra PS, GDE no 1533 dt. 25.03.22. At about 00-35 hrs we reached at Halal busty near river bank ,Kestopur under Bagdogra PS and we intercepted the vehicle on the basis of secret information and apprehended the driver of the said vehicle, but some others managed to flee away from the spot. During search it is found that the vehicle bearing No. WB-73-E-0279 was loaded with 23 (twenty three) numbers of Bullocks in different colour and size illegally. On being asked the driver of the said vehicle disclosed his name and address noted above and also stated that the cows were loaded on his truck at the direction of one Salam s/o Md Rafique resided at Halal busty , Kestopur to be taken to Fulbari side ,Jalpaiguri for sale. On asked, he failed to produce any valid License/ papers to carrying the said Bullocks in that vehicle and also failed to produce any papers in respect of the said Bullocks. On further checking it was found that there was no arrangement made for food and water for the Bullocks as per govt. rules which he was carrying in that vehicle. Besides, this there was no sufficient space for the Bullocks in that vehicle and all of them were tied with ropes. The above noted driver of the said vehicle also failed to produce any papers/documents in support of the said vehicle. Accordingly I seized the 23 (twenty three) numbers of Bullocks in different colour and sized and one Vehicle bearing Registration No WB-73-E-0279 and One mobile phone styled as VIVO, IMEI No. 865207036606676 & 865207036606668 under proper seizure list and arrested the above noted accused person U/S 41 Cr P.C , informing him the grounds of his arrest as he is violation of The Prevention of Cruelty to Animals Act 1960. The seizure and arrest have been made in between 00-45 hrs to 01.35 hrs.

Under the above circumstances, I pray to you that a specific case under proper section of Law may kindly be started against the accused person namely Karan Chouhan, (33) s/o Narayan Chouhan of Majlishpur PS, Goalpukur Dist, Uttar Dinajpur to arranged for its investigation.


