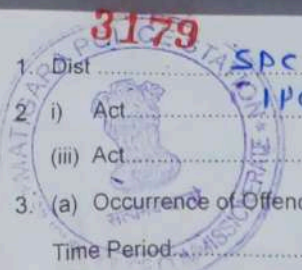

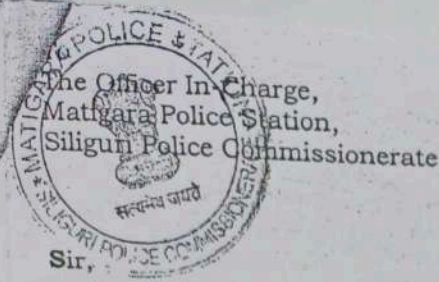

**Subject: FIR**

In producing herewith five (05) arrested accused persons namely (i) Robi Raj Bhar(25), S/O- Dinesh Raj Bhar of Ramkrishna Colony, Pati Colony, PO+PS- Matigara, Dist- Darjeeling, (ii) Rakesh Paswan(19), S/O- Lt. Ajoy Paswan of Tikia Para, PO+PS- Siliguri, (iii) Jibon Roy(22), S/O- Habul Roy of Sabita Bhawan, Ghughumali, PS- Bhaktinagar, Dist- Jalpaiguri, (iv) Roshan Biswakarma(22), S/O- Lal Bahadur Biswakarma of Mallaguri near Hanuman Mandir, PO+PS- Pradhan Nagar and (v) Md. Roshan Jamil(35), S/O- Abdul Salam of Adarsa Nagar, near Madrasa, PO+PS- Siliguri, Dist- Darjeeling arrested u/s- 41 Cr.P.C along with following seized articles viz:

- (1) One iron made improvised Firearm having its trigger, hammer and firing pin measuring approx 12 inch including its butt, body and barrel loaded with one live ammunition inscribed as "KF" and "72" on its percussion cap found from the possession of above noted Jibon Roy which was kept concealed on his back side and Marked as "Exhibit-A".
- (2) One live ammunition inscribed as "IK" and "9 9" on its percussion cap found inside the left side pocket of trouser of above noted Jibon Roy and marked as "Exhibit-B".
- (3) One iron made sword measuring 20 inch (approx) including wooden butt from the possession of Robi Raj Bhar which was kept concealed on his back side.
- (4) One iron made 'Knife' measuring 11 inch (approx) from the possession of Md. Roshan Jamil which was kept on his right hand.
- (5) One iron made 'Kukri' measuring 13 inch (approx) from the possession of Rakesh Paswan which was kept on his right hand.
- (6) One iron made Crowbars measuring 25 inch (approx) in length found from the possession of Roshan Biswakarma which was kept on his right hand.

I, PSI Shekhar Adhikary, S/O- Lt. Sonatan Adhikary of Matigara PS, Siliguri Police Commissionerate do hereby lodge this complaint against the above noted accused persons namely (i) Robi Raj Bhar, (ii) Rakesh Paswan (iv) Roshan Biswakarma and (v) Md. Roshan Jamil and others namely Uday Roy, Samir, Rajesh, Md. Sagar and Prasanjit to the effect that today on 27.03.2022 at 01.05 hrs received a sources information that 14/15 youths have assembled at Chandmoni Tea Garden back side of Chandmoni Temple under Matigara PS with a view to commit dacoity in a house at Uttarayan Township area. The fact was diarized in GD vide Matigara PS GDE No- 1632 dated 27.03.2022. Subsequently, after sharing the information with my superiors and as per their direction, I along with ASI Nitai Mandal, PSI Rantu Halder, PSI Abhishek Theengh, C/986 Rajib Sarkar, C/1035 Santosh Rabidas, CV/387 Sukumar Barman left for the place to work out the information. This refers Matigara PS GDE No. 1633, Dt. 27.03.2022. At about 01.25 hrs. after reaching near Chandmoni Temple under PS- Matigara I met my source and being pointed by the source we started walking towards Chandmoni Tea garden, back side of Chandmoni Temple. At 01.45 hrs. we reached at Chandmoni Tea garden, back side of Chandmoni Temple and started cordoning off the suspected persons as shown by the source with a strong reason to believe that they were preparing to commit some cognizable offence and were about to move from the spot seeing police personnel approaching towards them. They tried to flee away but on hot chase we managed to apprehend above noted five (05) accused persons along with seized articles as mentioned above. However, the other persons managed to flee away from the spot taking the advantage of darkness. On interrogation the accused persons admitted that they had assembled there to commit dacoity in a house at Uttarayan Township area.

I thereafter, seized the above noted weapons under proper seizure list and labelled duly signed by the witnesses and acknowledged by the accused persons. The whole seizure was made in between 02.25 hrs to 03.15 hrs. Thereafter, I arrested the above noted accused persons u/s 41 Cr.P.C under proper memo of arrests duly signed by the accused person and also supplied the copy of the memo of arrest to them.

I accordingly brought the arrested accused persons along with seized article at Matigara Police Station for further investigation. During the course of interrogation, it could be revealed from the arrested accused persons that they were gathered there to commit dacoity in a house of Uttarayan Township area. It is also revealed from them that Uday Roy, Samir Rajesh, Md. Sagar and Prasanjit and some others have assembled there with them and planned for committing the dacoity.

Hence, a specific case may kindly be started under proper section of Law against the above noted accused persons viz. (i) Robi Raj Bhar(25), S/O- Dinesh Raj Bhar of Ramkrishna Colony, Pati Colony, PO+PS- Matigara, Dist- Darjeeling, (ii) Rakesh Paswan(19) S/O- Lt. Ajoy Paswan of Tikia Para, PO+PS- Siliguri, (iii) Jibon Roy(22), S/O- Habul Roy of Sabita Bhawan, Ghughumali, PS- Bhaktinagar, Dist- Jalpaiguri, (iv) Roshan Biswakarma(22), S/O- Lal Bahadur Biswakarma of Mallaguri near Hanuman Mandir PO+PS- Pradhan Nagar and (v) Md. Roshan Jamil(35), S/O- Abdul Salam of Adarsa Nagar near Madrasa, PO+PS- Siliguri, Dist- Darjeeling (vi) Uday Roy, (vii) Samir, (viii) Rajesh, (ix) Md. Sagar, (x) Prasanjit and others and arrange for its investigation.


