With due respect, I SRI. LITON KUMAR SAHA, S/o. Late Kamini Mohan Saha, Respected Sir, resident of Janata Nagar, P.O. Sevoke Road, P.S. Bhaktinagar, Dist. Jalpaiguri beg to state that I had good relation with one Sri Gour Modak, S/o. Late Haripada Modak, resident of Janta Nagar, Ashikghat Road By Lane, Opp. Ballav Sarkar Medicine Shop, P.O. Sevoke Road, P.S. Bhaktinagar, District. Jalpaiguri had expressed me that due to urgent need of money, he has decided to sell his 3(three) decimals landed property, recorded in R.S. Khatian No. 1336, corresponding to L.R. Khatian No. 1730 & 1731. Pertaining to the R.S Plot No. 150 corresponding to the L.R. Plot no. 336, situated at Mouza -Kawakhali, P.S. Matigara, Dist. Darjeeling.

After perusing his ownership documents, I have entered into an agreement with said Gour Modak on 11th day of September, 2019 and he had agreed to sell his 3(three) decimals land to me subject to some terms and conditions mentioned in the said agreement. The consideration amount of the above mentioned land was settled a sum of Rs.4,80,000/-(Rupees Four Lacs Eighty Thousand) only and I have paid a sum of Rs.70,000/-(Rupees Seventy Thousand)only as an earnest money i.e. part of consideration amount and within 3 months from the date of 11/09/2019, he had agreed to execute the deed of sale in favour of me. However, Gour Modak, his son Dipankar Modak and his wife Kabita Modak have received part payment of consideration amount on several dates from me and lastly on 11/01/2021 and thereby they have received a total sum of Rs.3,00,000/-(Rupees Three Lacs)only as part payment of consideration from me.

That for extending the time period, said Gour Modak has again entered into a fresh agreement with me on 8th day of February 2022 and it was decided and agreed by Gour Modak that within 15th March 2022, he shall execute a deed of sale in my name and I shall pay the balance consideration amount to Gour Modak. In the said agreement, the wife and son of Gour Modak have also signed as witnesses. They have also given me the original copy of ownership deed in the name of Gour Modak. Surprisingly on 7th March 2022, when I have visited the above mentioned land, I found that one Smt. Bulbuli Roy is residing in and over the above mentioned land by constructing a house thereon and, I came to learn that Gour Modak has already sold and transferred the above mentioned land to the said Bulbuli Roy by executing a deed of sale being no. 1-7349 dated 04/10/2021 registered in the office of the A.D.S.R. Siliguri II at Bagdogra. Inspite of receiving part payment of consideration amount and inspite of entering into an agreement with me, said Gour Modak in collusion with his wife Kabita Modak and Dipankar Modak have sold the above mentioned land to a Third Party and

From the very beginning Gour Modak along with his wife Kabita Modak and agreement with me on 08/02/2022. Dipankar Modak had dishonest intention to cheat me and for that purpose they have induced me to pay part payment of consideration amount to them, even after selling the property to a third party. They have also committed criminal breach of trust as they have

Therefore, I request you to take necessary legal action against (1) Sri Gour Modak, dishonestly misappropriated my money. S/o. Late Haripada Modak, (2) Smt. Kabita Modak, (3) Dipankar Modak, all are resident of Janta Nagar, Ashikghat Road By Lane, Opp. Ballav Sarkar Medicine Shop, P.O. Sevoke Road, P.S. Bhaktinagar, District. Jalpaiguri for punishing them as per provision of law. And for this kindness, I shall much oblige to you.
