We due respect, I, Bablu Jaiswal S/o Rama Shankar Jaiswal of Kalabari Plash, PS Pradhan Sir, Nagar, Dist. Darjeeling, West Bengal, Pin No. 734003 and the owner of Punjab Golden Transport Company, which is situated at Nipania, Fulbari. I would like to lodge a written complaint that on 14/03/2022 one truck owner called me from mobile Nos. 9852830005 & 9915520947 to my mobile No. 9832454061 and requested me for loading his truck (PB19-H-9305). As per request of the truck owner and after verification of all the documents in respect of twelve wheeler vehicle bearing Regd. No. PB19-H-9305, then, I sent to Salugara Rabi Jaisawal for loading on 15/03/2022. I sent the said truck with proper Billty vide no. 386 to Rabi Jaiswal at Chayanpara Salugara Mart.

Thereafter, above mentioned truck loaded with Ms. Scrap valued Rs. 14,30,467 /- loaded from the Rabi Jaiswal, Chayanpara Salugara Mart. After loading said truck driver namely Baba Singh S/o Sawinder Singh of Thatha Batala, Gurudaspur, Punjab, 143602, along with the brother of truck owner namely Sukhdeep Singh S/O Amrit Singh of Ron Singhketala, Tehsil-Dera Baba Nanak, PS Kotli Surat Malli, Dist. Gurudaspur, Punjab left for Mandi Gabingarh, Punjab with the consignment. Usually five (5) days takes to reach the destination but after lapse of Ten (10) days the truck driver and brother of owner did not reach at destination and reached the consignment. I tried innumerable times to contact the driver Baba Singh and the brother of the owner of the truck Sukhdeep Singh in mobile number 9915520947 & 9852830005 but they could not be contacted and their whereabouts could not be traced. Found both mobile numbers switched off. I also contacted with the son of truck owner Davender Singh S/o Lakha Singh of Jaura Singha, Tehsil Batala, Gurudaspur Punjab in his contact number 9417673311 but he could say anything about the truck with consignment and the driver. I strongly believed that driver, brother of the truck owner and owner of the truck committed breach of trust and embezzled his whole consignment valued Rs. 14,30,467 /- only.

I therefore request you kindly lodge an FIR against the truck owner Davender Singh, driver Baba Singh and Sukhdeep Singh and take strong lawful action against them.
