Sir,

In producing herewith the one arrested accused person namely Nimai Byadh(29) s/o-Lt Lt Manilal Byadh of Hemkumari, Byadh Para, PS-Haldibari Dist-Cooch Bihar along with seized articles viz;

i) One orange colour plastic carry bag which contains three (03) medium sized packets, which is marked as Exhibit "A", Exhibit "B" and Exhibit "C", wrapped in off-white coloured paper. Each medium packets contained ten (10) pieces of small black packets with the picture of grapes on one side, with zip which contains 200 pieces, said to be YABA tablets each said to be contain Methamphetamine and caffeine, total being 6000 (six) thousand pieces and total weight 680 gm. Out of which three packets Exhibit "A", Exhibit "B" and Exhibit "C" from Exhibit "A", Exhibit "B" and Exhibit "C" respectively as sample each packet containing 200 pieces of YABA tablets.

ii) One mobile black colour black Zone vide IMEI No-911632952850251 and IMEI No-911632952850269 and attached one SIM contact number-7319096764

iii) Cash amount total Rs-6630/-

I beg to report that today on 27.03.22 at about 17.05 hrs, I SI Swadesh Saha of Detective Department, Siliguri police Commissionerate received source information that the above noted accused person is moving at near Amaidighi Check Post under NJP Police Station who is carrying narcotic substance in one orange colour plastic carry bag. Accordingly, the matter was diarized vide Detective Department, SPC GDE No. 101/22 Dtd 27.03.22. Accordingly informed the matter to my superior under the provision of Law. As per the direction at about 17.15 hrs, myself along with SI. Nur Alam Siddik, SI Amarta Chakraborty, ASI Abu Taleb, ASI Praloy Bhattachariya, C/371 Susanta Dey, all of Detective Department, Siliguri Police Commissionerate left for Amaidighi under NJP PS in Govt. vehicle driven by Govt. driver CD/ 598 Sibhu Das of DD, SPC to verify the authenticity of the information. This refers to D.D SPC GDE no. 102/22 dtd 27.03.22. At the time of departure from the office, I took investigation kits and all necessary requirements.

At about 17.45 hrs I along with officers and force reached at the desired spot near Amaidighi Check Post under NJP PS, Dist-Jalpaiguri and as indicated by the source, traced the person who was standing with a carrying orange colour carry bag. Without delay we cordoned the suspect and detained him. Accordingly, I managed two disinterested witnesses namely:- 1) Nazrul Islam s/o-Md Sanibullah of Pradhanpara, Fulbari PS-NJP Dist-Jalpaiguri 2) Maksud Ali s/o-Rahaman Ali of Do and I expressed the all matters as well as informed them to remain present at the spot during search and seizure if any. Both the witnesses agreed my proposal. I requested both the witnesses to search us and I also conduct search of both the present witnesses under relevant provision of Law but found nothing except wearing apparel. Then issued notices to the witnesses to remain present during search and seizure under provision of law. On interrogation he disclosed his name and address as noted above. After that I issued notices to the alleged detained person with a proposal to conduct search and seizure if any either in presence of Executive Magistrate or Gazetted officer, the alleged person acknowledged my notice and offered me to conduct search the alleged person noted above by the any gazetted/Executive Magistrate. Then I informed the matter to Sri Santanu Tarafder, ACP TRF (HQ) as a Spl Executive Magistrate, SPC with a request to remain present at the time of Search and Seizure. At 18.45 hrs he arrived at the spot and I disclosed his identity as a Spl Executive Magistrate before the alleged detained person and asked him to open the packets which was in the possession of Nimai Byadh(29) s/o-Lt Lt Manilal Byadh of Hemkumari, Byadh Para, PS-Haldibari Dist-Cooch Bihar.
