In producing herewith the following accuseds namely (1) Partha Sarkar (22) S/O Madhab Sarkar of Sukanta Nagar Auto Stand W/no. 38 PS Bhaktinagar Dist. Jalpaiguri (2) Sagar Rajbanshi @ Taklu (21) S/O Sri Ujjal Rajbanshi of South Ektiasal Gouranga Pally W/no. 40 PS Bhaktinagar Dist Jalpaiguri (3)Rajen Pandit @ Chhatu (19) S/O Sri Raju Pandit of do and (4)Shubhojit Adhikari @ Bidyut (22) S/O Sri Narottam Adhikari of Ashighar Coloney PS Bhaktinagar Dist. Jalpaiguri in custody along with the following seized articles:-

- i. 01 (One) improvised Single shooter fire Arms made of iron measuring approx 19 ½ inches in length including its butt 4 inches, body 4 inches and barrel 13 ½ inches approx and consisting of trigger and firing pin loaded with one .303 live ammunition marked as K6 8MM on percution cap was recovered from the possession of Partha Sarkar (22) S/O Madhab Sarkar of Sukanta Nagar Auto Stand W/no. 38 PS Bhaktinagar Dist. Jalpaiguri which was found tagged in the waist of the full pant of Partha Sarkar
- ii. One (1) Ramdah made of iron measuring approx 2(Two) feet 7(seven) inches length including wooden handle was recovered from the possession of accused Sagar Rajbanshi @ Taklu (21) S/O Sri Ujjal Rajbanshi of South Ektiasal Gouranga Pally W/no. 40 PS Bhaktinagar Dist Jalpaiguri
- iii. One (1) iron made Chopper measuring approx 16(Sixteen) inches length including handle recover from the possession of accused Rajen Pandit @ Chhatu (19) S/O Sri Raju Pandit of South Ektiasal Gouranga Pally W/no. 40 PS Bhaktinagar Dist Jalpaiguri.
- iv. One (1) house breaking implement made of iron with pointed end measuring about 21" in length was recovered from the possession of accused Shubhojit Adhikari @ Bidyut (22) S/O Sri Narottam Adhikari of Ashighar Coloney PS Bhaktinagar Dist. Jalpaiguri.

I, S.I Pradip Kr Singha of Ashighar OP P.S Bhaktinager would like to lodge this written complaint against the above noted accused persons and also 10/11 other unidentified persons to the effect that today i.e. on 28.03.2022 at about 21.05 hours received a secret source information that a group of 14-15 persons have assembled at Chota Fapri football ground near forest, under Bhaktinager P.S, Dist-Jalpaiguri with deadly weapons with a view to commit some heinous crime. Accordingly without wasting any time I informed the matter to O/C Ashighar OP and diarised the whole fact in Ashighar OP GDE No.648 dated 28.03.2022, Then at 21.10 hrs, as per instruction of O.C Ashighar OP I along with ASI Ujjal Mandal, ASI Amit Mallick, C/877 Munna Ahmed, CV/1016 Amrit Roy all of Ashighar OP left for spot to verify the veracity of the information and to work upon it, noted in Ashighar OP GDE NO. 649 Dt- 28.03.2022. We reached near the spot as directed by the source at about 21.35 hours and stopped at a considerable distance from above noted spot and we started walking towards the P.O with due care so that no one could anticipate our movement. On way we meet two respectable persons of the locality namely (1) Sujit Roy (31) S/O Late Satish Roy of Naresh More Telipara PS Bhaktinager dist. Jalpaiguri and (2) Ajay Sarkar (31) S/O Sunil Sarkar of Niranjan Nagar w/no. 36 PS Bhaktinagar Dist. Jalpaiguri and to whom we disclosed our motto and identity and asked them to accompany us if any search and seizure is necessary for the purpose and they agreed. We reached at Chota Fapri football ground near forest, at about 21.50 hrs and found a group of 14/15 persons sitting at Chota Fapri football ground near forest.We started approaching towards them slowly ambushing ourselves in the darkness. But unfortunately one of the people among the gang saw us and shouted "Police" at the top of his voice. Thereafter all of them started fleeing away. Anyhow, after a hot chase we could able to apprehend the 04 above referred accused persons. After

Apprehension the 04 persons disclosed their identity as noted above and also stated that there were 10/11 other persons with them and they were planning to commit a dacoity on the house of a businessman at Baneshwar More area. Thereafter all the apprehended persons were searched in presence of the witnesses and the following articles were seized as follows:-

- i. 01 (One) improvised Single shooter fire Arms made of iron measuring approx 19 ½ inches in length including its butt 4 inches, body 4 inches and barrel 13 ½ inches approx and consisting of trigger and firing pin loaded with one .303 live ammunition marked as K6 8MM on percution cap was recovered from the possession of Partha Sarkar (22) S/O Madhab Sarkar of Sukanta Nagar Auto Stand W/no. 38 PS Bhaktinagar Dist. Jalpaiguri which was found tagged in the waist of the full pant of Partha Sarkar
- ii. One (1) Ramdah made of iron measuring approx 2(Two) feet 7(seven) inches length including wooden handle was recovered from the possession of accused Sagar Rajbanshi @ Taklu (21) S/O Sri Ujjal Rajbanshi of South Ektiasal Gouranga Pally W/no. 40 PS Bhaktinagar Dist Jalpaiguri
- iii. One (1) iron made Chopper measuring approx 16(Sixteen) inches length including handle recover from the possession of accused Rajen Pandit @ Chhatu (19) S/O Sri Raju Pandit of South Ektiasal Gouranga Pally W/no. 40 PS Bhaktinagar Dist Jalpaiguri.
- iv. One (1) house breaking implement made of iron with pointed end measuring about 21" in length was recovered from the possession of accused Shubhojit Adhikari @ Bidyut (22) S/O Sri Narottam Adhikari of Ashighar Coloney PS Bhaktinagar Dist. Jalpaiguri.

Thereafter all the articles were seized in-between 22.05 hrs to 22.25 hrs. Issuing a proper seizure list duly signed by the witnesses and the accused persons. Thereafter all the persons were arrested after observing all formalities of arrest as they are assembled for committing heinous crime.

On the above circumstances, I pray before you that a specific case may kindly be started against the 04 arrested accused persons namely (1) Partha Sarkar (22) S/O Madhab Sarkar of Sukanta Nagar Auto Stand W/no. 38 PS Bhaktinagar Dist. Jalpaiguri (2) Sagar Rajbanshi @ Taklu (21) S/O Sri Ujjal Rajbanshi of South Ektiasal Gouranga Pally W/no. 40 PS Bhaktinagar Dist Jalpaiguri (3)Rajen Pandit @ Chhatu (19) S/O Sri Raju Pandit of do and (4)Shubhojit Adhikari @ Bidyut (22) S/O Sri Narottam Adhikari of Ashighar Coloney PS Bhaktinagar Dist. Jalpaiguri and 10/11 others unidentified persons for such assemble with deadly weapons & fire arms and arrange for its investigation.
