Subject: Complaint against Illegal Occupancy Claim of Tribal Land and threat to grab Scheduled Tribe Land.

Respected Sir,

I, Baganu Tirkey, son of Lt. Bhakru Tirkey, recorded raiyat/owner of the subject plot of land which is recorded and accordingly mutated in the Land Revenue Records belonging to Scheduled Tribe, sub-caste "Oraon" and permanent resident of Mariam Nagar, Jhauguri, New Chumta, Darjeeling District, would like to draw your kind attention to the fact that I have a shop in the front of my residence which I Darjeeling in the year 2014 in a verbal negotiation of amount of Rs. 4000 (Rupees Four Thousand Only) per month which was under his occupancy till 2019.

I would like to inform you that in 2019 Md. Rafikul ended the verbal agreement which was decided verbally over faith based on good and healthy relationship and he handed over the shop and the key to me in a peaceful manner and the matter was closed. However, he had stopped paying the rent within one year of taking possession of the said shop. During the life time of the said Rafikul Hussain he never claimed title over the said shop room and Rafikul Hussain died in June. 2021.

Now again, as I began to renovate and reconstruct my shop in February, 2022 which was already vacated by Md. Rafikul in 2019; 1. Md. Safikul Hussain (the brother of Md. Rafikul Hussain), 2. Md. Samsul Hussain (the nephew of Md. Rafikul Hussain) and 3. Imran Hussain (son of Md. Rafikul Hussain) appeared at my residence, disturbed me and put obstruction in the construction and threatened me, my sons and used foul language against me, my sons and my daughter in law. The above named persons shop described as: Plot No. 14 in Mouza – Khopalasi, Police Station Matigara in District Darjeeling and New Plot numbers: 161, 162 & 163 recorded in Khatian No. 2255, Mouza – Khopalasi, J.L. No. 91 (Schedule of the Land enclosed herewith). You are requested to note that no such agreement was eligible to buy Tribal being non tribals. The above mentioned persons have continued to come to my grab our land at any cost. These are purporting to rely on false and fabricated documents. While I was trying to renovate and reconstruct my shop they disturbed and threatened me of dire consequence.

The above mentioned persons 1. Md. Safikul Hussain, 2. Md. Samsul Hussain and 3. Imran Hussain (son of Md. Rafikul) asked me to give them registration of the subject plot of land by threatening me and my family members. The said persons also abused me and my family members in filthy languages

such as "witch", "uncivilized", "Adivasi lower Caste", "jangli", "randi ka baccha" and many more words of such nature. The said goons appeared in my house multiple times, also in my absence and have pushed and touched my daughter-in-law during such confrontation and threatened me by saying that they would kidnap my said daughter-in-law from our house and rape her in case of not registering the said land to them. The nature of their threat is so severe that my wife and daughter in law have stopped going out of house since the day they have threatened us in such manner. They are not only denying me my right of enjoying my own Scheduled Tribe land but also is putting a hindrance in the daily life and mental well

Therefore in regard to the aforementioned facts and circumstances, it is my earnest request to you to register an F.I.R. against the said Imran Hussain, Safikul Hussain and Samsul Hussain and take immediate necessary action so that I can complete my construction without any disturbance for which I shall be ever grateful to you.
