In producing herewith arrested accused person named Dharbindar Sharma (36), S/O – Ram Bahadur Sharma, of – Kalam Jote near Apna Ghar, PO – Sushruta Nagar, PS – Matigara, Dist – Darjeeling along with memo of arrest, original seizure list and seized articles viz (i) 10 (Ten) Sealed bottles of Himalayan Gold 60Up Country Spirit containing 600 Ml each @ Rs. 120/- each (totaling amount of Rs. 1200/-) marked as exhibit "A" out of which one bottle taken as sample and (ii) 06 (Six) Sealed bottles of Himalayan Gold 60Up Country Spirit containing 300 Ml each @ Rs. 60/- each (totaling amount of Rs. 360/-) marked as exhibit "B" totaling amount of Rs. 360/- out of which one bottle taken as sample.

The fact of the case is that today on 29.03.2022 at 18:15 hrs received source information that one Dharbindar Sharma (36), S/O – Ram Bahadur Sharma, of – Kalam Jote near Apna Ghar, PO – Sushruta Nagar, PS – Matigara, Dist – Darjeeling have stored huge quantity of ID liquor at his house illegally for sale to the People for his wrongful gain.

I informed the matter to O/C NBMC OP and as per his direction I along ASI Preambhakta Mallick, C/402 Abhishek Gupta & C/228 Joydeb Mahanta left for Kalam Jote to work out the information. At about 18.55 hrs held raid at the house Dharbindar Sharma (36), S/O – Ram Bahadur Sharma, of – Kalam Jote near Apna Ghar, PO – Sushruta Nagar, PS – Matigara, Dist – Darjeeling and on search (i) 10 (Ten) Sealed bottles of Himalayan Gold 60Up Country Spirit containing 600 MI each @ Rs. 120/- each (totaling amount of Rs. 1200/-) and (ii) 06 (Six) Sealed bottles of Himalayan Gold 60Up Country Spirit containing 300 MI each @ Rs. 60/- each (totaling amount of Rs. 360/-) have been recovered. On demand he could not produce any documents / License for possession such quantity of I.D liquor. On interrogation he confessed that he stored the said I.D liquor illegally for sale to the interested persons for his wrongful gain.

So, I seized the said (i) 10 (Ten) Sealed bottles of Himalayan Gold 60Up Country Spirit containing 600 Ml each @ Rs. 120/- each (totaling amount of Rs. 1200/-) and (ii) 06 (Six) Sealed bottles of Himalayan Gold 60Up Country Spirit containing 300 Ml each @ Rs. 60/- each (totaling amount of Rs. 360/-) in presence of witnesses under proper seizure memo and arrested him U/S 41 Cr.P.C.

Under the above circumstances I pray before your kind self that a specific case under proper section of law may kindly be initiated against the accused person named Dharbindar Sharma (36), S/O – Ram Bahadur Sharma, of – Kalam Jote near Apna Ghar, PO – Sushruta Nagar, PS – Matigara, Dist – Darjeeling and kindly arranged for its investigation.
