
Dear Sir,

I have immediately blocked the SIM and obtained a new SIM of same number from the authorised stores. There is CCTV camera in the Building of my neighbour, Smt. Nabinita Mukherjee, and in the CCTV footage one person is seen around 4 AM roaming in the complex. This person is suspected as one Raju (Mobile Number 7864008392). This Raju has worked as plumber in my house. It has also come to my knowledge that this Raju has been arrested few months back in dacoit case and he was in jail for many days. I do hereby submit the CCTV footage in a pen drive.

Therefore, it is requested to please take the necessary legal action against said Raju to stop such incident in the society in near future.
