In producing herewith the arrested accused person namely Promod Sahani (23) S/O Akhil Sahani of Hath Colony, Tikiapara, Ward No. 28, PS- Siliguri, Dist- Darjeeling along with seized article vize-

- One improvised iron made 7.65 mm Pistol measuring approx 8.5 inches from barrel to butt having hammer and trigger marked as Exhibits –A,
- Two rounds ammunition engraved KF 7.65 unreadable on its percussion cap (found loaded in SI No.1 seized exclusively from possession of accused Promod Sahani, Marked Exhibits-A1.

I, SI Uday Chakraborty of Siliguri Police Station, Siliguri police Commissionarate do hereby lodge this complaint that on 28.03.22 at around 20.35 hrs, received a secret source information that one person was moving suspiciously at Hatath Colony more with an ulterior motive and is in possession of firearms. Dairsed the mater vide Siliguri PS GD entry no. 1976 dated 28.03.22. Accordingly I informed the matter to the I/C Siliguri PS and as per your kind instruction I along with ASI Siben Sarkar, ASI Subir Sen, ASI Dhruba Misra, CV/283 Prosenjit Dey, and CV/ Ramanth Barman, all of Siliguri P.S. rushed to the place at Hatath Colony more under vide Siliguri PS GDE No. 1977 dated 28.03.22 and on way picked up two disinterested witnesses namely (i) Md. Hasan (30 yrs) S/O Md Kausor of Hatah Colony, Tikiapara, Ward No. 28, PS- Siliguri, Dist- Darjeeling and (ii) Shiva Paswan (22 yrs)S/O Rajendar Paswan of do, duly informing them about the information in hand. At 20.55 hrs I along with force reached at Hatath Colony more and as per identification by the source, myself along with force managed to apprehend the person. On being asked, the apprehended person disclosed his identify as noted above.

Accordingly, as per information and following all necessary procedures of search of the police person in presence of witnesses, search of the apprehended person Promod Sahani was made. On search one improvised iron made 7.65 mm Pistol loaded with 02 (two) ammunition engraved KF 7.65 unreadable on its percussion cap was recovered, which was kept concealed under his Pant ,on the right side of his below the waist. The ammunitions were unloaded from the firearms as per practical experience. On being asked about the possession of the firearms, the apprehended Promod Sahani made incoherent statements.. On being asked he failed to produce any valid documents in respect of said Fire Arms. On further interrogation he stated that he had procured the said Fire Arms illegally with intend to sale under Siliguri area for his wrongful gain.

As there is every reason to believe that the recovery firearms loaded with two round ammunitions has been procured dishonestly by the apprehended Promod Sahani for his ulterior motive, seized the firearms and two round ammunitions duly taking its measurements and details in presence of the witnesses duly signed by them and acknowledge by the apprehended Promod Sahani and arrested him following all formalities. The seizure/label has done between 21.25 hrs to 22.35 hrs.
