Sir,

In producing herewith one arrested accused person namely Ananda Das (20) S/O Sri Ganesh Das of Laxmi Colony, Dasarathpally (Behind Payel Cinema Hall), Ward No-44, PS Bhakti Nagar, Jalpaiguri along with the seized articles as per seizure list:-

1. One improvised one shutter iron made fire arm in working condition measuring approx 10 inches from barrel to wooden butt having striking pin, hammer and trigger.
2. One live ammunition engraved OK 04 72 unreadable on its percussion cap (found loaded in SI No 1) seized exclusively from the possession of above noted accused.

I SI Ashim Kumar Das of Panitanki TOP under Siliguri Police Station, Siliguri Police Commissionerate do hereby lodge this complaint that today on 30/03/22 around 21:35 hrs, I received a secret source information that one of the wanted criminal of crime against property namely Ananda Das S/O Sri Ganesh Das of Laxmi Colony Dasarathpally (Behind Payel Cinema Hall), Ward No-44, PS Bhakti Nagar, Jalpaiguri is roaming beside the Mahananda River bed behind Surya Sen Park with an ulterior motive and is in possession of firearm. Diarised the matter in Panitanki TOP vide Panitanki TOP GD entry no-622 dated 30/03/22. Then at 21:45 hrs as per kind instruction of OC Panitanki TOP I along with ASI Surajit Mallick, ASI Biswajit Ghosh, C/984 Subhasish Das and C/153 Santosh Mahato all of Panitanki TOP under Siliguri PS took departure to workout the information. This refers Panitanki TOP MCC No-420/22 dated 30/03/22 and GDE No-623 dated 30/03/22. At 22:05 hrs we rushed to the spot at Mahananda River bed beside Suryasen Park area under PS Siliguri and on the way we called two disinterested witnesses namely (1) Apu Barman (42) S/O Sri Radha Ballav Barman of Mahakalpally, Near Suryasen Park, Ward No-10, PS Siliguri, Darjeeling, and (2) Arindam Sanyal (30) S/O Sri Dhananjay Sanyal of do duty informing them about the information in hand. Then after arrival, as per description of the wearing apparels supplied by the source, we apprehended the person noted above with all precautionary measures. On being asked, the apprehended person disclosed his identity as Ananda Das S/O Sri Ganesh Das of Dasarathpally (Behind Payel Cinema Hall), Ward No-44, PS Bhakti Nagar, Jalpaiguri.

Accordingly, as per information and following all necessary procedures of search of the Police person by the witnesses, search of the apprehended persons was made. On search one improvised one shutter iron made fire arm loaded with one round live ammunition was recovered from his exclusive possession, which was kept concealed under the trouser on the left side of his waist. The ammunition has been unloaded from the firearm as per practical experience. On being asked about the possession of the firearm and ammunition, the apprehended made incoherent statements.

As there is every reason to believe that the firearm and ammunition recovered has been procured dishonestly by the apprehended person noted above for his ulterior motive. Accordingly seized the firearm and ammunition duly taking its measurements and details in presence of the witnesses duly signed by them and acknowledge by the apprehended person's and arrested him following all formalities. The seizure has done between 22:20 hrs to 22:35 hrs.

Under the above circumstances, I pray that a specific case under Arms Act may kindly be started against the arrested person namely Ananda Das (20) S/O Sri Ganesh Das of Laxmi Colony Dasarathpally (Behind Payel Cinema Hall), Ward No-44, PS Bhakti Nagar, Jalpaiguri and arrange for its investigation.
