Sir.

In producing herewith Five (05) arrested accused persons namely (i) Bapi Sarkar (36) S/O Lt. Pradip Sarkar of Shantinagar, Boubazar, P.S- Bhaktinagar, Dist.- Jalpaiguri, (ii) Nepal Biswas (20) S/O Ashok Biswas of Nepali Busty, P.S- NJP, Dist.- Jalpaiguri, (iii) Bikash Thapa (34) S/O Bimal Thapa of Shibnagar Colony, P.O+P.S- Pradhannagar, Dist- Darjeeling, (iv) Kartik Roy (22) S/O Rabi Roy of Sukantapally Gas Godown, P.S- Matigara, Dist.- Darjeeling and (v) Md. Tamanna (31) S/O Lt. Md. Majibul of Sukantapally Gas Godown, P.S- Matigara, Dist- Darjeeling arrested u/s- 41 Cr.P.C along with following seized articles viz:

(1) One iron made Crowbar measuring 26 inch (approx) in length from the possession of Bapi Sarkar which was kept on his right hand,

(2) One iron made sword measuring 30 inch (approx) including wooden handle from the possession of Nepal Biswas which was kept concealed on his back side,

(3) One Iron rod measuring 40 inch (approx) in length from the possession of Bikash Thapa which was kept on his right hand,

(4) One Iron rod measuring 30 inch (approx) in length from the possession of Kartik Roy which was kept on his right hand

(5) One iron made Knife measuring 12 inch (approx) including wooden handle from the possession of Md. Tamanna which was kept concealed on his back side

(6) Two iron rod measuring 40 inch and 25 inch (approx) in length seize from the place of occurrence.

I, PSI Abhishek Theengh of Matigara PS, Siliguri Police Commissionerate do hereby lodge this complaint against the above noted accused persons namely (i) Bapi Sarkar, (ii) Nepal Biswas, (iii) Bikash Thapa, (iv) Kartik Roy, (v) Md. Tamanna, and (vi) Md. Sagar, (vii) Md. Amir and others to the effect that today on 31.03.2022 at 00.25 hrs received a sources information that 10/12 commit docoity in a house at Mohamaya Colony. The fact was diarized in GDE vide Matigara PS with a view to GDE No-1830 dated 31.03.2022. Subsequently, after sharing the information with my superiors and as per their direction, I along with ASI Nitai Mandal, C/986 Rajib Sarkar, C/1035 Santosh information.

At about 00.45 hrs after reaching Near Chamta Bridge, Old Matigara Road, P.S- Matigara I met my source and as pointed by the source we started approaching towards the spot and cordoning off the suspected persons as shown by the source with a strong reason to believe that they were preparing to commit some cognizable offence. But, seeing the police party approaching above noted five (05) accused persons namely (i) Bapi Sarkar, (ii) Nepal Biswas, (iii) Bikash Thapa, above. However the other persons managed to flee away from the spot taking the advantage of darkness. On interrogation the accused persons admitted that they had assembled there to commit dacoity at Mohamaya Colony. It is also revealed from them that Md. Sagar, Md. Amir and some others have assembled there with them and planned for committing the dacoity.
