Respected Sir,

I, **MEGHIA SINGH**, W/O Suraj Kumar Singh, D/O Vijay Singh, presently resident of Rajibnagar, ward No. 46, P.O. & P.S. - Pradhan Nagar, Dist. Darjeeling, I do hereby want to inform you as follows :-

1. That I lodge this F.I.R to the effect that on 01.03.2020, I was married to Suraj Kumar Singh, S/O Shivanandan Singh, resident Baribhasa, V.I.P. Road, Behind Raju Bakery, P.O. Sahudangl, P.S. - Bhaktinagar, Dist. Jalpaiguri.
2. That the members of my matrimonial house are my husband **SURAJ KUMAR SINGH**, father-in-law namely **SHIVNANDAN SINGH**, mother in law **KUSUM DEBI**, sister-in-laws **POOJA SINGH & LAXMI SINGH**, and relative brother-in-law namely **DICKKY SINGH**, MAMA namely **TULSI SINGH** who used to stay in my matrimonial house.
3. That during the marriage negotiations, my husband demanded cash dowry of Rs. 4,00,000/- from my father, and my father has given the cash dowry of Rs. 2,50,000/- (Rupees Two Lakh Fifty Thousand Only) to my husband. Moreover, gold amounting Rs. 4,00,000/- (Rupees Four lakh) only, Furniture amounting Rs. 2,00,000/- (Rupees Two Lakh) only along Godrej, Television, Refrigerator worth Rs. 1,50,000/- (Rupees One Lakh Fifty Thousand) only, utensils worth Rs. 50,000/- (Rupees Fifty Thousand), which has been handedover to my father-in-law namely **SHIVNANDAN SINGH** and Mother-in-law namely **KUSUM DEBI**, in presence of the other relatives.

That soon after marriage my husband and my father-in-law started to torture me both mentally and physically and pressurized me to bring money from my father and when I refused to comply his demands my husband bang my head on the wall by forcefully putting towel into my mouth so that I cannot scream. Moreover, my husband always used to humiliate me in all respect and in spite of fulfilling all their dowry demands my husband was never happy with me and always used to taunt me as I had brought insufficient dowry. I was treated like a servant from the very beginning and not given the status of a wife. I was bearing all the torture of my husband with a hope that everything will be alright in future but everything was in vein.
5. That my mother in law and sister-in-laws abused me in most filthy language and even tried to kill me by keeping the gas oven open in the kitchen when I went to make tea in the evening. I was saved due to my own alertness. My husband and mother in law began to abuse and insult me and my family members in front of neighbors and they all took advantage of the fact that I could not express all these in front of my parents or any other family members. Through out of the day I was tortured by my husband, mother in law and sister-in-laws and at night if I dared to ask my husband for help he used to beat me and accuse me for not bringing enough dowry.
6. That this is also to inform you that when I was sick with cough, cold and fever but my husband, my father-in-law, my mother in law and sister-in-laws refused to take me to any doctor and at night when I told my husband to get the medicines, he got me some sleeping pills and told me to take all the said pills and die.
7. That thereafter whenever my brother used to come to my matrimonial home to see me, my husband, my mother in law and sister-in-laws used to doubt on my character with my brother, and started to beat me mercilessly.
8. That after that one of my brother-in-law namely **Bickky Singh** and Mama namely **Tulsi Singh** used to force me get involve with them physically whenever the other family members used to remain absent in the house and when I refused their lustrous proposal they used to disrobe my modesty by pulling my clothes, forcefully hold me and also used to click pictures, blackmailed me to spread those picture in the social media.

9. That when I informed the said matter to my husband, then the said brother-in-law namely **Blekky Singh** and **Mama** namely **Tulsi Singh** along with father, mother and sisters in law bang my head on the wall by forcefully putting towel into my mouth so that I cannot scream.
10. That subsequently I became pregnant and during the pregnancy my husband slapped me on my face, in front of father-in-law, mother-in-law, sister-in-laws and brother-in-law and none of the members of my matrimonial house came to rescue me or provided me with the first-aid rather they are instigating my husband to beat me and by that way miscarriage may occur but somehow I managed to rescue myself at that time from the grip of my husband and my in-laws above named.
11. That after the said incident my parents went to my matrimonial house but my husband and other in-laws humiliated my parents in filthy languages and thrown them out of the house.
12. That subsequently out of our wedlock one female child namely **Sakshi Singh** was born on **22.03.2021**. After the birth of my female child I thought that everything will be alright nothing got right instead of that the my in-laws always taunted me. My above mentioned in laws never ever took any information about me during my delivery time as it was a female child and not even at the time of giving birth of the child. My husband and other in laws were never ever wanted the birth of my female child and even after her birth of the female child my husband and other in laws never happy and nor contacted with me nor my husband provided any kind of maintenance to me and the infant baby. I was passing my days with a hope that everything will be alright in future. Being in such a fatal situation I somehow managing to bring up the baby.
13. That recently on **06.05.2021** my husband and the above named in laws informed me and my father that they will never accept me and my infant baby as their daughter in law and also they are very much in process of arranging remarriage of my husband.
14. That after that due to the intervention of the well wishers was meeting was being arrange for settling the dispute between the family members and after that my father took me to my matrimonial home with my infant baby and my husband and in-laws humiliate my father with abusive languages and demanded **Rs. 2,00,000/- (Rupees Two lakh)** only if my father is willing to continue my matrimonial life.

15. That when my father express his inability to fulfill there demand my husband and my other in-laws above named started to torture me both physically and mentally by abusing me with filthy languages and when I protested the same then they refuse to provide me with any food and also to my infant baby and also beat me mercilessly.
16. That when I started to protest against the torture of my husband and the above named in-laws my husband became very furious and started to keep me and my infant baby in a lock and key condition within the house and not even provide sufficient food and other necessities to me and my infant baby.
17. That thereafter my husband and my other in-laws started to give me some medicines forcefully with an intention to make me mentally imbalance and my husband very often abuse and insult me and my family members and accuse me for not bringing enough dowry in front of neighbours by taking the advantage of the fact that I could not express all these in front of my parents or any other family members.
18. That thereafter the torture increases day by day upon me as well as upon my infant baby but I tolerate all the torture with a hope that everything will be alright in future. Moreover the above named persons restrained me to go to my matrimonial house and subsequently I forced me to do all the household work after my delivery so that I suffer from severe pain and the only intention of my in-laws to kill me and my infant baby out of starvation.
19. That after that my brother passed away in a accident and when I informed the said matter to my husband and my in-laws and requested my husband to take me to my parental home then my husband started to beat me mercilessly and kicked me out of my matrimonial house along with my infant baby.
20. That when I called my husband to take me back to my matrimonial house, my husband and the above named in laws informed me and my father that they will never accept me and my infant baby and also they are very much in process of arranging remarriage of my husband.

21. That at present I am living in very depressed condition and became mentally and emotionally ruined due to the above mentioned cruel acts and conducts of my husband and I am in very much fear that my husband and my other family members may kill me and my infant baby.

I therefore request before your good self to kindly look into the matter and take strict necessary action against my husband **BURAJ KUMAR SINGH**, father-in-law namely **SHIVNANDAN SINGH**, mother in law **KUSUM DEBI**, sister-in-laws **POOJA SINGH & LAXMI SINGH**, and relative brother-in-law namely **BICKKY SINGH**, MAMA namely **TULSI SINGH**, as per the provision of law and for this act of kindness I shall remain extremely grateful to you.
