In producing herewith two accused persons namely 1] Rahul Trikhatri (31) s/o Dilip Trikhatri of Thakur Bari, MAsjid Road, PS Kalimpong, Dist. Kalimpong and 2] Diwakar Darnal (30) s/o Puran Darnal of Lower Bhanu Nagar, Near Gupta Apartment, Ward No. 43, PS Bhaktinagar, Dist Jalpaiguri under custody and the following seized articles viz;

1] Twenty Three Kilogram and Two Hundred and Fifty Grams (23.250 Kg) of said to be Ganja packed, sealed and marked as "Exhibit-A".

Seized the above noted articles from the joint possession of possession of accused persons namely 1] Rahul Trikhatri (31) s/o Dilip Trikhatri of Thakur Bari, MAsjid Road, PS Kalimpong, Dist. Kalimpong and 2] Diwakar Darnal (30) s/o Puran Darnal of Lower Bhanu Nagar, Near Gupta Apartment, Ward No. 43, PS Bhaktinagar, Dist Jalpaiguri.

I, SI Sk Tamzid Ali of Bhaktinagar PS/SPC do hereby lodge this written complaint to the effect that on 01.04.2022 at around 19.25 Hrs I, received a secret source information that two persons namely Rahul Trikhatri and Diwakar Darnal are standing with one white colour Big sack at Sahid Nagar More suspected to have some contraband articles inside their Big sack and they were about to move from that place towards Bhanunagar to dispose it clandestinely, and if acted immediately they may be apprehended red handed. Accordingly I, diarized the matter vide Bhaktinagar PS GDE No. 46, Date. 01.04.2022 and informed to I/C Bhaktinagar PS and as per his kind order at about 19.35 Hrs I along with PSI Sailesh Subba, ASI Rabin Lama, ASI Dipak Karmakar, C/762 Mujibul Rahaman, CVF/614 Sumit Roy left from PS along with investigation kits to verify the veracity of the source information. This refers to Bhaktinagar PS GDE No. 47, Dated 01.04.2022 and MCC No. 825, Dated. 01.04.2022. On the way I briefed the whole team about the information and organize a plan for its execution.

On the way towards Sahid Nagar More I, called two independent witnesses namely 1] Amit Kumar Chhetri s/o Late Bijoy Chhetri of Upper Bhanu nagar, Near Kath Mill, Ward No. 43, PS Bhaktinagar, Dist. Jalpaiguri and 2] Raj Mahato s/o Sakal Deb Mahato of Bhanu nagar, Near Green Valley Apartment, Ward No. 43, PS Bhaktinagar, Dist. Jalpaiguri and informed them about the information in written and requested them to accompany with us as witness during search and seizure if necessary. They agreed to accompany us during the whole period of raid. At around 19.45 Hrs I accompanied with the whole team and along with two independent witnesses arrived at Sahid Nagar more and contacted my source over mobile phone and from a far distance and in presence of street light my source pointed and identified the said persons who were holding one big white plastic sack from both sides. As shown and identified by my source, I arrange all the forces to cordon the identified persons from all sides to prevent them from escaping. Further I, along with my accompanied team intercept and managed to apprehend both of them at Sahid Nagar More.

I introduced the apprehended persons as a Police officer and the accompanying team as police personal. On being asked about their name and address they disclosed their identity as 1] Rahul Trikhatri (31) s/o Dilip Trikhatri of Thakur Bari, MAsjid Road, PS Kalimpong, Dist. Kalimpong and 2] Diwakar Darnal (30) s/o Puran Darnal of Lower Bhanu Nagar, Near Gupta Apartment, Ward No. 43, PS Bhaktinagar, Dist Jalpaiguri. After maintaining the decency of apprehended persons searched their whole body by the accompanying team but found nothing except wearing apparels. Further on being asked

about the content of the sack which they were possessed. They denied to disclose the content of the sack to the Police team. Further, on grilling them, they revealed that they have possessed Ganja inside the sack. I, asked them in written whether they have any objection to be searched the content of the bag in presence of any Executive Magistrate or Gazetted Officer and in return they agreed to be searched his sack in presence of any Gazetted Officer. I, served him a notice in accordance with the provisions of law in this regard. Then at 20.00 Hrs I, apprise Shri Amaresh Singh, Inspector Incharge of Bhaktinagar Police Station, and SPC and requested him to be remain present at the spot as a Gazetted Officer for search and seizure of the articles.

At 20.10 Hrs. Shri Amaresh Singh, Inspector Incharge Bhaktinager Police Station, SPC arrived at the spot and disclosed his identity as Inspector of Police as Gazetted Officer to the accused persons. At around 20.20 Hrs under the supervision of Shri Amaresh Singh, Inspector Incharge Bhaktinagar Police Station, SPC and the above noted witnesses searched the aforesaid accused person keeping strict regard of his decency and found nothing except wearing apparel and on being searched of the sack which they were possessing found. He further confessed in presence of Gazetted Officer and other witnesses that he has clandestinely procured the recovered Ganja from Siliguri area for the purpose of selling for their wrongful gain. On interrogation both of them confessed that they have been engaged in this illegal act since long and has been importing it from different places of Siliguri and selling the same to its adjacent areas. On being asked they failed to produce any documents or license in support of the possession of such contraband atrticles. Then as per direction of Shri Amaresh Singh, Inspector Incharge Bhaktinager Police Station, SPC and in presence of witnesses I, weighed the recovered articles said to be Ganja by a weighing machine (not certified) and the total weight of the articles along with the sack weighs 23.250 kg (Twenty Three Hundred Kilogram and Two Hundred Fifty Grams). I packed, labeled and sealed the sack in presence of witnesses, and marked as "Exhibit -A" and seized recovered articles as alamat under proper seizure list duly signed by the witnesses as well as the accused persons. The seizure was made in between 20.45 hrs and 21.40 hrs. Then, I arrested the above noted accused persons after appraising them the ground of arrest. The copy of seizure list and memo of arrest have been supplied to the above noted accused person. Thus, the arrested accused persons have violated the terms and conditions of N. D. P. S Act. for possessing this restricted Narcotics drugs without any legal authority.

Under the above circumstances, I pray before you that a specific case under proper section of law may kindly be registered against the arrested accused person namely 1] Rahul Trikhatri (31) s/o Dilip Trikhatri of Thakur Bari, MAsjid Road, PS Kalimpong, Dist. Kalimpong and 2] Diwakar Darnal (30) s/o Puran Darnal of Lower Bhanu Nagar, Near Gupta Apartment, Ward No. 43, PS Bhaktinagar, Dist Jalpaiguri.and arrange for its investigation.
