I Kabita Barman, W/o Sri. Ratan Barman, D/o Dhanubala Barman, presently residing at Allin Nagar, Nich Para Chorongi More, P.O. & P.S. Matigara, Dist - Darjeeling, Pin - 734012, W.B. would like to inform you that I got married with Ratan Barman S/o Bhiwisan Mandal at about 20 years ago by following our Hindu rites and customs at the above mentioned address. At the time of marriage we thought that my husband is well educated, independent and very sensible person and at the time of our marriage we were fulfilled all the demands like cash amount of Rs. 1,00,000/- and also handed over Rs. 3000/-, Jewellery, furniture etc. of my husband and his family members.

After marriage started to live with my husband and my father-in-law namely Bhiwisan Barman, my mother-in-law namely and my brother-in-law namely Madhab Barman at my matrimonial house at Madhya Shital Kuchi, Satipukur, P.S. Shital Kuchi, Dist - Coochbehar, Pin - 736158, W.B. Since after marriage, my husband and my in laws used to unbearable torture on me without any reasons and also assaulted me. They also used to abuse me by using filthy language and demand money from my house.

But inspite of this incident happened I used to keep silent and tolerated all inhuman torture by my husband and my in laws. One day my husband was trying to kill me by pouring 2 litre Kerosene oil and also fed poison forcibly but luckily I got safe from that trap and I came back my home at Silliguri but my two sons namely Samir Barman aged about 18 years and Shukumar Barman aged about 16 years, were in their father's house at Shital Kuchi, Coochbehar.

I want to take custody of my two son's and among them one son is handicapped and i think that they would not take care my son's. On 24 th March, 2022 he had came to my house for taking me back at his house back but when denied to go he beat me.

In such circumstances finding no other alternative I come before you with this present complaint and request you to take necessary action in respect of the above stated facts as per law and to help me for get justice.
