After marriage started to live with my husband and my father-in-law namely Bhiwisan Barman, my mother-in-law namely and my brother-in-law namely Madhab Barman at my matrimonial house at Madhya Shital Kuchi, Satipukur, P.S. Shital Kuchi, Dist – Coochbehar, Pin – 736158, W.B. Since after marriage, my husband and my in laws used to unbearable torture on me without any reasons and also assaulted me.
