I, **Sri Saiyam Goyal**, son of Late Ramesh Goyal, resident of Neel Kamal Apartment, Pranami Mandir Road, Haiderpara, Siliguri, Ward No. 40, Post Office:- Sevoke Road and Police Station:- Bhaktinagar, District:- Jalpaiguri, PIN:- 734001 would like to lodge a written complaint against the above named miscreant stating as follows:-

That on 15.04.2021 I on behalf of my principal **Sri Ratan Kumar Agarwal**, son of Deoki Nandan Agarwal, resident of Geyzing Bazar, Geyzing, Police Station: Gyalshing, in the district of West Sikkim had lodged a written complaint against the above named miscreant stating that above said miscreant was trying to take the illegal possession of landed property of my principal with the help of his men and agents. It is pertinent to mention here that my principal is the owner of piece and parcel of land measuring 26.90 decimals appertaining to and forming part of L.R. Plot No. 185 & 187, of L.R. Sheet No. 209 recorded in L.R. Khatian No. 12 of Mouza: Dabgram, Police Station: Jalpaiguri, in the district of Jalpaiguri.

That recently, since 24.03.2022 the above named miscreant once again with the help of his men and agents have started disturbing the peaceful possession of our landed property by attempting to fix bamboo sheets on the said landed property of my principal.

That it is pertinent to mention here that the above named miscreant based on some false documents have filed a suit being TS Suit No.50 of 2019 before the Ld. Civil Judge Senior Division at Jalpaiguri against my principal and three others and in the said suit Ld. Court has passed an order of **Status-quo** and directed both the parties not to change the nature and character of suit land and despite of pendency of the order of the Ld. Court the above named miscreant is disturbing the peaceful possession of our landed property.
