I Smt. Swapna Barman, W/o. Ranjan Barman, and Daughter of Nirmal Barman, resident of C/o. Khoka Sarkar, Naresh More, P.S Bhaktinagar, Dist. Jalpaiguri, would like to inform you that, I have entered into the marriage with Ranjan Barman, S/o. Ananda @ Mohini Barman on 18.01.2021 according to Hindu Rites & Customs at the house of my parents situated at Bholajali, P.O Tarbandha, P.S Phansidewa, Dist. Darjeeling.

I would like to further inform you that at the time of said marriage my father had given a Motor Cycle (Hero Glamour) alongwith gold ornaments, a steel Khat, steel Almirah, steel dressing table alongwith a cash of a sum of Rs. 15,000/- to my husband and same has been received by my husband, and after the said marriage my husband brought me in a rented house of Sri Khoka Sarkar situated at Naresh More, P.S Bhaktinagar, Dist. Jalpaiguri.

I would like to further inform you that, after elapsing of some days of my marriage, my husband started to physical and mental torture upon me, even every night he consumes alcohol and after consuming alcohol he started to abusing filthy languages towards my family members and also beaten me by fist and blows. Thereafter I became pregnant and after hearing the said news my husband started to ignoring me and finding no other alternative I contact with my parents and request them to taking proper care of me and my child in womb.

I would like to further inform you that, at the time of Durga Puja festival my parents brought me in their house and on 15.10.2021 I gave birth of a girl child at Phansidewa Gramin Hospital but it was very shocked for me that my husband denied to expense of any medical expenditure of me and my new born girl child just because my child was a girl child and finding no other alternative my father clears all the expenditure.

I would like to further inform you that after elapsing of two months I voluntarily came back to the said rented place of my husband and started to reside there, and I found there is a massive change of my husband, always he used filthy languages, not even any time he touched my girl child. On 15.03.2022 my husband Sri Ranjan Barman told me that he went to work but after elapsing of considerable time he did not returned to the said rented place, and when I started to called him, he blocked my phone calls.
