I, Smt. Dorothis Ekka wife of Late Ajit Kumar Ekka, resident of Mariyam Nagar, Khopalashi Jote, P.O. New Champta T.E. Police Station Matigara, District: Darjeeling being a member of Schedule Tribe do hereby lodge this complaint against the following accused persons namely:

- (1) Mukesh Sah, son of Ram Narayan, resident of Kopalashi, Chunha Bhatti, Police Station: Matigara, District: Darjeeling.
- (2) Md. Sahid, son of Late Md. Munna, resident of Jali Basti, Kopalashi, P.S. Matigara, District: Darjeeling.
- (3) Md. Kalim (Sonu), father's name not known, resident of Kopalashi, Haria More, P.S. Matigara, District: Darjeeling.
- (4) Above named accused persons are headed by Krishna Singh, son of late Kishori Singh resident of Jhouguri, Police Station: Matigara, District: Darjeeling.

With due regard I the above named petitioner most respectfully beg to states for your kind attention and consideration in the following facts as under: -

- (i) That myself along with 5 (five) others are the co-shearer of the below scheduled of land measuring 1.142 acres or more or less 3 (three) Bighas 9 (nine) Kathas out of land measuring 3.97 acres or more or less 12 (twelve) Bighas Agricultural Land by virtue of inheritance and we have been peacefully enjoying and possessing the said land since 1990 and our names are recorded in separate L.R. Khatians being No. 503, 504, 506, 507, 508 and 509.
- (ii) That on 31/03/2022 at about 7:30 A.M. the above named Accused persons along with their associates forcefully entered into our land with JCB Tractors and damaged our land and tried to grab our said landed properties but after getting information about the incident we immediately came to our said land and strongly opposed them, then they fled away with threatened to us saying that they would take the possession of our land and if any obstruction is done they would assault us even if necessary they would kill us.
- (iii) That it is pertinent to mentioned here that I filed one Civil Suit against the accused no. 4 for permanent injunction being Title Suit No. 129 of 2011 which is still pending before the Ld. Civil Judge Senior Division, Siliguri and there is an order of maintaining status-quo.
- (iv) That the above named accused persons are known as land mafia of the locality and the highly influential and dangerous in nature, so they have tried to grab our said land for their illegal gain and local people are not coming forward to restrain them due to fear. They have also fire arms in their possession and it is known to the local residents.
- (v) If we oppose them there is every possibilities for losses lives and properties by the above named accused persons as because they were anti-social in nature and they have no regards about the law of the Country.




- (vi) That we are belongs to Schedule Tribe in community and the accused persons were all in General Caste so they are openly threatening us with malicious intention for their illegal gain and in future they will further try to enter in our said land to grab the same and we shall have to oppose and then there every possibilities for breach of peace, tranquility and riot there is also chances for losses lives and properties for their criminal activities.

Under the above circumstances it is humbly prayed to your good self to be kind enough to accept this F.I.R and to take necessary strict and vigil action against the above noted accused persons and to save us and our properties as from the clutches of accused persons for the end of justice.


**SCHEDULE OF THE LAND**




