Sir,

In producing herewith one arrested accused person namely 1. Prasant Oraon 20 yrs s/o Laharu Oraon R/o Kamalpur Tea Garden Ps, Bagdogra Dist Darjeeling along with seized articles viz (1) One improvised fire Arms one shutter measuring approx its length 25 cm including butt, body and barrel, and (2) One .303 live ammunition.

I SI Binup Mahato of Bagdogra PS, Siliguri Police Commissionerate do hereby lodge a written complaint against the above noted one accused person to the effect that on 03.04.2022 at 22-15 hrs received a secret source of information that one person were coming from Islampur side by possessing with one improvised fire Arms waiting behind the Gour Netai Mistanna Bhandar Biharmore for sale the same to his designated customer for his wrongful gain illegally and noted the same in GD vide Bagdogra PS GDE No. 145 Dated 03.04.22. Accordingly, I informed to O.C. Bagdogra PS about the information and as per his direction at 22.25 hrs myself along with ASI Dharendra Nath Barman, C/410 Montosh Singh, CV389 Janak Singh, CV- 923 Pandit Nagasia, VP-02 Pradip Roy and K-36 Night van party left for Bihar More area behind the Gour Netai Mistanna Bhandar to verify the veracity of the information vide Bagdogra PS G.D.E. No. 146 dtd. 03.04.2022. At about 22.35 hrs we reached at Bihar More and meanwhile we called two independent witnesses namely 1. Mukesh Sah 22yrs s/o Satnarayan Sah of Hospital more 2. Guddu Thakur 24yrs s/o Kheyali Thakur of Nunujote Chowpukuria both Ps Bagdogra Dist. Darjeeling and disclosed them our identity and informed them about the information and requested them to accompany us in the whole process during search and seizure, if any. After reaching the spot we ambushing our self after some time source pointed out one person, who was moving in suspicious manner behind the Gour Netai Mistanna Bhandar gali road seeing the police team he tried to flee away to run from the spot a hot chase somehow my team managed to apprehended the said person and on being asked he disclosed his identity as mentioned above.

During search, his possession, one improvised fire Arms one shutter which concealed on his back side of waist and one .303 live ammunition which was kept on his right side pant pocket have been recovered. On being asked he failed to produce any valid license or documents in respect of possessing of the said arms. On further interrogation, he admitted that the improvised fire Arms one shutter and .303 ammunition he had procured from Panjipara Dist. Uttar Dinajpur with intend to sale the same for his illegal gain to his designated customers. Accordingly, I seized the said one improvised fire Arms one shutter measuring approx its length 25 cm including butt, body and barrel, and one .303 live ammunition under proper seizure list duly signed by the witnesses and accused person and packed, labelled & sealed on the spot. The seizure was made in between 23.05 hrs to 23-35 hrs. Then, I arrested the above noted accused person u/s 41 CrPC inform his ground of arrest after observing all formalities to violate the possessing of fire arms and ammunition.

I therefore, pray before you that a specific case may kindly be started against Prasant Oraon 18 yrs s/o Lalu Oraon R/o Kamalpur Tea Garden Ps Bagdogra Dist Darjeeling accused person and arrange for investigation.
