Sir,

In producing herewith one (01) arrested accused person namely Suraj Chettri @ Kanchha (22) S/O Lt. Sosti Chhetri of Sukanta Pally, Gas Godown, P.S- Matigara, Dist.- Darjeeling (not verified) along with the following articles under seizure as per seizure list;

1. One iron made improvised one shutter Firearm having its trigger, hammer and firing pin measuring approx 8.5 inch including its butt, body and barrel loaded with one number of ammunition inscribed as "OK", "07" and "7.2". [The articles have been found kept concealed on the right side of waist of accused Suraj Chhetri marked as "Exhibit- A"]
2. One live ammunition inscribed as "KF" and "8 MM" on its percussion cap found inside the left side pocket of blue colour jeans pant of accused Suraj Chettri @ Kanchha & marked as "Exhibit- B"]

I, SI Newton Biswas, S/O- Nirmal Biswas of Matigara Police Station, Siliguri Police Commissionerate do here by lodge this written complaint against above noted one (01) arrested accused person namely Suraj Chettri @ Kanchha to the effect that today on 03.04.2022 at about 16.50 hrs I received a specific source input that one person is standing near Jorabridge, Tumbajote under Matigara P.S for committing heinous crime. He used to carry and possess small arms & ammunition with him. The matter was diarized vide Matigara PS GDE No. 128 Dt. 03.04.2022. Accordingly, I informed the matter to the Officer-in-Charge, Matigara Police Station. Subsequently, as per his kind direction myself along with ASI Tapan Das, ASI Nitai Mandal, Const- 1008 Kanak Roy, C/986 Rajib Sarkar all of Matigara PS and along with investigation kit left for Jorabridge, Tumajote by govt. vehicle to verify the veracity of the information. This refers Matigara PS GDE No. 129 Dt. 03.04.022 and MTG PS MCC No. 54/2022 Dt. 03.04.2022. Under this circumstance any search warrant or authorization cannot be obtained without affording opportunity for the concealment of evidence or facility for the escape of the offender.

On way to Jorabridge, Tumbajote, I contacted two persons namely (i) Ratan Barman (40) S/O Ramani Kanta Barman and (ii) Reeru Khan (41) S/O Lt. Ilius Khan, both of Tumbajote, Beldangi, PS- Matigara, Dist- Darjeeling and make them aware of the information in hand and requested them to act as witness, if any search and seizure would be made necessary upon which they agreed.

Thereafter we along with the independent witnesses reached near Jorabridge, Tumajote at 17.45 hrs and being pointed by my source apprehended the above noted accused person named Suraj Chettri @ Kanchha and searched him immediately and found the above noted articles from his conscious and exclusive possession. On demand he failed to produce any document in support of his possessing and carrying of such type of fire arms and ammunitions. Hence, it is evident that the accused named Suraj Chettri @ Kanchha exclusively & consciously possessed this improvised fire arms loaded with live ammunition illegally with some ill motives.

Thus, his involvement in carrying and possessing illegal fire arm is established, I seized and labelled the above noted articles at the spot under proper seizure list duly signed by him as well as by the above noted independent witnesses and also put my signature on the seizure list and label. The seizure and label was made in between 18.10hrs. to 18.45 hrs. I also arrested him preparing memo of arrest informing him ground of his arrest.


From the above noted facts and seizure of incriminating articles there is strong reason to believe that the accused Suraj Chettri @ Kanchha has carried the said fire arms loaded with live ammunitions with an objective to commit heinous crime in the locality.

Under the above circumstances, I pray to you that a specific case under proper section of law may kindly be started against the accused person namely Suraj Chettri @ Kanchha (22) S/O Lt. Sosti Chhetri of Sukanta Pally, Gas Godown, P.S- Matigara, Dist.- Darjeeling (not verified) and arrange for its investigation.
