I am **Debashis Biswas** Son of Bablu Biswas Lower Bhanu Nagar, Sevoke Road, Siliguri Ward No-43, P.S. Bhakti Nagar, Dist: Jalpaiguri

30.03.2022, Yesterday, on the way to house Bhanu Nagar, At a Vanue of Suryenson Park in the river bank area, It was around 7-0'clock in the evening time, Gangs were started following me and abusing me constantly from behind. They had a Red color Scotty Active (WB 74 AP 2204) & Black Color Glamour (WB 74 Q 0438) suddenly overtook me and surrounded me. I seen that 5 people were present in the spot, I knew two person **Suman Daptari** (Home Adress-Jhankar More, WARD NO-07 Koyala dipu, Son of Khalekh Daaptari) and **Bhola Ghosh** (Home address-Jalpai More shitla Para, WARD NO 31) started hitting me with bad intension in a very brutally way. They hit me on the head with Deadly Weapon (iron rods) and my gold chain and Rs. 10,000 cash snatched at the same place and threw me in an impassable position on the bank of the river and fled.

So, Requested to you, Kindly look into this matter and take sufficient action from your end as soon as possible.
