Sir,

In producing herewith the two (02) persons namely (1) Rajkumari Devi (55) W/O- Rabindar Sahani of Darbhanga Mithaoli PS- Singmara, Dist- Darbhanga and (2) Babita Devi (23) W/O- Dashrath Sahani of Bijay Chhapra PS- Khaiyapur, Dist- Chhapra (Bihar) along with seized articles viz :-

- (1) 25 (Twenty five) bottles of Royal stag Barrel Select whisky each bottle containing 750 ML (printed price valuing Rs. 770 each bottle total 19,250/-), which was inside the luggage trolley Red Colour Bag.
 - (2) 06 (Six) bottles of Royal Challenge Premium Gold Whisky each bottle containing 750 ML (printed price valuing Rs. 730 each bottle total 4,380/-), which was inside the luggage trolley Red Colour Bag.
 - (3) 75 (Seventy Five) Puch Packet of Officer Choice Deluxe Whisky each containing 180ML (printed price valuing Rs. 130 each bottle total 9,750/-), which was inside the Black Colour luggage Bag.
- (Total amounting Rs- 33, 380/-)

I ASI- Niranjan Sarkar of Khalpara TOP under PS Siliguri, Siliguri Police Commissionerate would like to lodged this written complaint against the above noted persons. Today (02.04.2022) at 17.25 hrs received secret source information that one vehicle having Regd. No- BR 37F/1737 AITIANA Bus two passenger caring the huge quantity of foreign liquor is proceeding towards Samastipur, Bihar side from Siliguri under Siliguri PS area. Accordingly after apprising the information to I/C Siliguri PS as per his direction I along with ASI Sanjoy Hasda, ASI Kalachand Singha, ASI Md. Aminul Islam, C/ 874 Nagen Tamang C/239 Badal Barman, LC/1216 Pushpanjali Yanzon, LCV/1058 Pratima Chhetri, had been to Burdhawan near Brahma Kumari under PS Siliguri at about 17.40 hrs and able to detain the said vehicle i.e. BR 37F/1737, coming from Siliguri junction side. Subsequently on being checked the above noted vehicle and shown by the source two lady passenger with four bags with loaded huge quantity of foreign liquor in side the bags. Then I search the said lagged bags with the help of lady force and found the possession of above noted persons.

Further on being asked the apprehended persons disclosed their identity as above and failed to produce any valid documents/papers in support of the above noted articles and transportation of the same. On interrogation they stated that they were taking the above noted articles to Samastipur, Bihar with a view to sale the same in the area where the Govt has banned selling of liquor for illegal gain. They also revealed that they are running this illegal liquor smuggling to Bihar for their wrongful gain for last few months. This is to be mentioned here that the Bihar Govt. has imposed total prohibition on use of liquor by enacting Bihar Excise (Amendment) Act, 2016 within the state since 05.04.16. Then I seized the above mentioned articles under proper seizure list and labelled. Subsequently I arrested the above mentioned persons. The seizure has been made in between hrs 17.55 hrs to 18.35 hrs.

Therefore I pray before your good self that a specific case against the above noted accused person namely (1) Rajkumar Devi (55) W/O- Rabindar Sahani of Darbhanga Mithaoli PS- Singmara, Dist- Darbhanga and (2) Babita Devi (23) W/O- Dashrath Sahani of Bijay Chhapra PS- Khairapur, Dist- Chhapra (Bihar) may kindly be initiated under proper section of law and may cause for its investigation.
