Sir,

I, SI Sanjoy Hasda of Khalpara TOP under PS- Siliguri, SPC do hereby lodge this written complaint against two (02) persons (1) Bikash Ram (19/M) S/O Dilip Ram of Samastipur, Jidwarpur, PS- Samastipur, Dist- Samastipur(Bihar), and (2) Abhishek Kumar (18/M) S/O Sri Upendar Ram of Samastipur, Jidwarpur, PS- Samastipur, Dist- Samastipur (Bihar), after producing him under arrested and one iron made improvised Fire Arms having its trigger and firing pin measuring approx 13 inch including its butt, body and barrel loaded with one point 303 ammunition inscripted as "KF-72" on its percussions cap of the ammunition. Length of ammunition is approx 3 inch.

In this regard I beg to complain that today on 02.04.2022 at about 22.15 hrs. received a secret information that one person had been waiting at Jhankarmore near traffic point under PS- MSiliguri for committing heinous crime, they used to carry and possess small arms & ammunition with them. Diarised the information vide Khalpara TOP GDE No.792 Dated- 02.04.22 and shared it with the I/C Siliguri PS and O/C Khalpara TOP-II.

Following their directions myself along with SI- Subhendu Das, ASI Kalachand Singha, Const 541 Santosh Kumar Roy, Const- 239 Badal Barman, CV.05 Gobinda Das all of Khalpara TOP, SPC left for Jhankar more under PS- Siliguri to work out the information. We reached at the spot. As shown by my source we cordoned the area and could be able to apprehend two young boy. We searched them immediately and found one improvised small fire arm loaded with one live ammunition from back side of Bikash Ram waist under cover of his wearing apparel, and two live ammunition from Abhishek Kumar right pocket. On interrogation they disclosed their name and address as noted above. they admitted that they was collect the said Fire Arms from Bihar for sell it to one unknown person in high price. they exclusively possessed this improvised fire arm loaded with one live ammunition illegally with some ill motives. On demand they failed to produce any valid document in support of their possessing and carrying of such type of fire arm.

Thus when they involvement in carrying and possessing illegal fire arm established, I arrested them preparing memo of arrest informing their ground of arrest and also I seized one improvised fire arm loaded with one live ammunition and two round live ammunition under proper seizure list duly signed by him as well as by available witnesses namely (i) Khokon Ghosh (35/M) S/O Nikhil Ghosh of Vidhyasagar nagar, Ward No.07, PS- Siliguri, Dist- Darjeeling and (ii) Md. Islam @ Nathuni (54/M) S/O Late Md. Douḍ of Santoshinagar, Ward No. 04, PS- Siliguri, Dist- Darjeeling who were present there at that time.

From the above noted facts and seizure of incriminating articles there is strong reason to believe that the accused persons are a desperate and dangerous persons. They were carrying the said fire arms loaded with live ammunition with an objective to commit heinous crime in the locality.


So, I pray before you for starting a case against (1) Bikash Ram (19/M) S/O Dilip Ram of Samastipur, Jidwarpur, PS- Samastipur, Dist- Samastipur(Bihar), and (2) Abhishek Kumar (18/M) S/O Sri Upendar Ram of Samastipur, Jidwarpur, PS- Samastipur, Dist- Samastipur (Bihar), under appropriate section of law as they has wilfully violated the regulation of Arms Act and for arranging its investigation.
