Sir,

In producing herewith one (01) arrested accused person namely Ajay Saha (28 yrs), s/o -Lt. Ajit Saha of Michel Madhusudan Colony, PS- NJP, Dist - Jalpaiguri along with the seized articles as per seizure list;

1. One improvised one shutter iron made fire arm in working condition measuring approx 9 inches from barrel to butt having striking pin, hammer and trigger,
2. One live ammunition engraved but unreadable on its percussion cap (found loaded in SI No (1) seized exclusively from the possession of accused.

I ASI Sanjoy Saha of Milanpally OP under NJP PS, Siliguri Police Commissionerate do hereby lodge this complaint that on 02/04/2022 around 22:15 hrs, received a secret source information that one of the wanted criminal of crime against property namely 1) Ajay Saha (28 yrs), s/o -Lt. Ajit Saha of Michel Madhusudan Colony, PS- NJP, Dist - Jalpaiguri is roaming at Teesta Barrage area under Milanpally OP with an ulterior motive and is in possession of firearm. Diarised the matter vide Milanpally OP GD entry no - 51, dated 02/04/2022 and as per your kind instruction I along with ASI Biswajit Adikary, ASI Dipak Singha, C/694 -Sushil Saibo, C/980 - Sadhan Barman all of Milanpally OP under NJP PS rushed to the place at Teesta Barrage area PS NJP and on way picked up two disinterested witnesses namely 1) Uttam Sarkar, s/o - Ratan Sarkar of 18 No Milanpally, PS- NJP, Dist - Jalpaiguri 2) Arjun Mandal, s/o - Lt. Amulya Mandal of -Do- duly informing them about the information in hand, At 22:25 hrs reached Teesta Barrage area and as per description of the wearing apparels supplied by the source, apprehended the person noted above with all precautionary measures. On being asked, the apprehended person disclosed his identity as noted above.

Accordingly, as per information and following all necessary procedures of search of the police person by the witnesses, search of the apprehended person was made. On search one improvised one shutter iron made fire arm loaded with one round live ammunition was recovered, which was kept concealed under the trouser on the left side of his waist. The ammunition was unloaded from the firearm as per practical experience. On being asked about the possession of the firearm and ammunition, the apprehended person made incoherent statements.

As there is every reason to believe that the firearm and ammunition recovered has been procured dishonestly by the apprehended person noted above for his ulterior motive, seized the firearm and ammunition duly taking its measurements and details in presence of the witnesses duly signed by them and acknowledge by the apprehended person and arrested him after following all formalities. The seizure has done between 22:40 hrs to 22:55 hrs.
