With due respect, I am producing herewith the arrested accused persons namely (i) Rabi Sahani (30 yrs) S/O late Dayal Sahani of Bagrakote, Hatat Colony, Ward No 28, PS- Siliguri, Dist- Darjeeling (ii) Md Riyaz (27 yrs) S/O Md Rafike of Raja Howli, Ward No-35, PS- NJP, Dist- Jalpaiguri (iii) Basanta Kr Rai (25 yrs) S/O Mitra kr Rai of Kamjer Busty, PO+PS+Dist- Kalimpong A/P Kashmir Colony, PS- NJP, Dist- Jalpaiguri and (iv) Bishal Sarkar (19 yrs) S/O Biswanath Sarkar of Santi Para, PS- NJP, Dist- Jalpaiguri and the following articles under seizure :-

I, ASI Sajal Das of NJP PS, Siliguri Police Commissionerate beg to state that on 04.04.22 at 01.05 hrs I received a secret source information that a gang of miscreants come to Baribhasa thanghbanga More near Abhinandan Sangha with deadly weapons and assembled there and making preparation for committing dacoity at Madani Bazar area. Accordingly, I informed the fact to the Officer-In-Charge, NJP PS as well as Asstt Commissioner of Police, East -II, SPC and diarized the fact in General diary vide NJP PS GDE No 153 dated 04.04.22. As per the kind order and direction of my superior officer myself along with ASI Khagen Barman, C/1053 Paresh Rava, HG/794 Ranjit Roy, VP/13 Jamirul Islam, VP/08 Laxman Roy, CV/306 Bisawajit Roy, CV/116 Rohit Kr Mahato and CV/824 Niru Yadav left for Baribhasa near Abhinandan Sangha to work out the information in hand. I also informed the fact to night RT Van officer PSI Ajoy Pradhan and requested him to come to Baribhasa Thangbhanga More near Abhinandan Sangha to accompany with us. At about 01.35 hrs on 04.04.22 we arrived at Baribhasa Thangbhanga More near Abhinandan Sangha and after a few time night RT van officer PSI Ajoy Pradhan along with force came to Baribhasa Thangbhanga More near Abhinandan Sangha and accompany with us. At about 01.55 hrs we noticed that 08/09 persons assembled in a dark place at near Thangbhanga More, Baribhasa and they were whispering in a very low voice. Accordingly we cordoned the place properly and approach towards them very slowly and carefully. But seeing the police party they started to flee away but we the police party managed to apprehended 04 (four) of them. On interrogation the apprehended accused persons disclosed their name and identity as noted above. During interrogation they give different statement in different time and failed to give any satisfactory reply for their presence with deadly weapons in the middle of the night.
