Sir,

In producing herewith the accused person namely Rajat Mahato (28yrs) , S/O Sri Lalan Mahato of South Shantinagar ,Jabravita PS New Jalpaiguri Dist. Jalpaiguri and following seized fire arms and ammuniton as noted below ----

- i. One(01) <sup>28y</sup> Prohibited improvised single shooter fire Arms having butt , body, barrel and striking pin, made of iron, total length 8 ½ inches loaded with one .303 live Ammunition marked as OK 04 7X on percussion cap was recovered from the waist of accused Rajat Mahato .

I SI Pradip Kr Singha beg to lodge this written complaint against the above noted arrested accused to the effect that today on 04.04.2022 at 18:15 hrs. received a reliable source information that one person is coming from NJP side having improvised fire arms and ammuniton and who is supposed to sale it to some other person clandestinely. The dealing of fire arms will be made at Binay More bazar area . I diarised the fact in G.D. vide Ashighar OP G.D.E. No -84 Dated - 04.04.2022 and informed the matter to O/C Ashighar OP . As directed by O/C Ashighar OP myself along with ASI Inzamamul Hoque, ASI Sumit Baran Nath , C/877 Munna Ahmed and CV/1016 Amrit Roy all of Ashighar OP. taking the Govt. vehicle no. - WB42/R 8829 left for Binaymore bazar area to work out the information at 18:25 hrs. which refers to Ashighar OP. G.D.E. No. - 85 Dated - 04.04.2022 . At 18:55 hrs we reached at Binay More and we disclosed our motto to (1) Dilip Das (37 yrs.) , S/O Kali Charan Das of Ghogomali Near Jagatbandhu Ashram PS Bhaktinagar Dist. Jalpaiguri and (2) Ajay Sarkar (32) S/O Sunil Sarkar of Badurbagan PS Bhaktinagar Dist. Jalpaiguri. who were found at Binay More . I requested them to accompany us to witness search and seizure if any made . They agreed and accompanied us. Taking the witnesses we proceeded towards Binay More bazar . As indicated by my source we reached near the shed of Binay More bazar and kept watch from a little distance over there. At about 19:35 hrs. one young person having dirty look arrived under the shed of Binay More bazar on foot . We gradually proceeded nearer to the shed of Binay More bazar , but seeing us the said person tried to flee away from the spot but somehow we managed to detain him . On search we found one improvised single shooter fire Arms loaded with one round of cartridge on his waist. On being

demanded by me he failed to produce any valid documents for possessing such fire arms and ammunition. Accordingly, I seized the same as alamat under proper memo of seizure duly authenticated by the witnesses and took into custody. I also arrested the said person who disclosed his name and identity as noted above. The search, seizure and arrest were made in between 19:55 hrs. to 20:25 hrs. I also prepared label for the fire arms and one cartridge

Under the above noted circumstances, I pray, a specific case against the above noted accused person may kindly be started under proper section of law and arrange for its investigation.
