Sir,

In producing herewith one arrested accused person namely (1) Kamal Pandit (20)S/O Lalit Pandit of Rajendranagar Coolipara ,PS- Pradhannagar, Dist Darjeeling under arrest along with the seized following articles:-

- i) One improvised one shooter small fire arms with iron butt measuring 24cm (approx) from barrel to butt, barrel length 12.5 cm (approx), butt length 8 cm (approx), body length 9cm (approx) having one striking pin, striking hammer and trigger in working condition ,marked as Exhibit-"A"
- ii) One round ,Live ammunition 8 MM which was loaded in the improvised Fire arms ,marked as "A-1".

I PSI Sumit Sarkar of Pradhannagar PS under Siliguri Police Commissionerate would like to lodge this written complaint against Kamal Pandit (20)S/O Lalit Pandit of Rajendranagar Coolipara ,PS- Pradhannagar, Dist Darjeeling to the effect that today on 03/04/2022 at 18.50 hrs. I received a source information that, one person is roaming at Mahanda Colony near Diesel shed under Pradhannagar PS area possessing illegal firearms with a view to commit some heinous crime. Accordingly, the fact was diarized vide Pradhannagar PS GD Entry No. 169 date 03/04/2022 and I informed the fact to you. As per your direction myself along with ASI Debasish Das,ASI Tarun Kanti Ghoh C/ 974 Minty Sen , CV/128 Ajoy Kumar Sahani, CV/223 Swapan Chettri all of Pradhannagar PS left from PS for Mahananda Colony with vehicle No- WB 74AC-9851 to verify the veracity of the information, vide PDN PS GDE No.170 at 19.00 hrs .

On the way to Dharam Nagar, I called two witnesses namely (1) Suraj Routh S/O Ram Avtar Routh of Mahananda Colony,Ward No.1,P.S- Pradhannagar,Dist.Darjeeling and (2) Azad Khan S/O Lt Abdul Rauf Khan of Biswas Colony,P.S-Matigara,Dist.Darjeeling . and narrated them the information in hand after disclosing our identity and requested them to accompany with us as witnesses. Accordingly, they had given their consent and become willing to accompany with us. We reached near the spot as identified

by the source at about 19.25 hrs. and intercepted and apprehended the above noted person. On interrogation he disclosed his identity noted above. Then I searched the person as per provision of law and on searching recovered above noted improvised firearms loaded with one round ammunition from the exclusive possession of Kamal Pandit which he kept conceal position in the back side of his waist.

On demand he was unable to produce any valid documents or license in support of his possession of Arms and ammunition. He also admitted that he has procured the fire arms and ammunition illegally for committing illegal activities by entering in to a criminal conspiracy with his associates to commit crime against property. Accordingly the above noted firearms and ammunition are recovered and seized in between 19.45 Hrs to 20:35 hrs under proper seizer list in presence of the witnesses duly signed by them and acknowledge by the apprehended person. There after sealed and labeled the seized the articles. Then I arrested the above noted accused person after communicating the ground of arrest and issuing necessary memo of arrest for violating the specific provision of Arms Act.

Under the above circumstances, I pray before you that a specific case may kindly be started against the arrested accused person namely Kamal Pandit (20)S/O Lalit Pandit of Rajendranagar Coolipara, PS- Pradhannagar, Dist Darjeeling under proper section of law and cause its investigation.
