With due respect and humble submission I, PSI Krishna Parja of Pradhan nagar PS, SPC do hereby lodge this complain against one Saroj Manna (47) s/o Lt. Aditya Manna of Madhab Chowk, PS-Sabang, Dist- Paschim Midnapore to the effect that on 04.04.2022 while performing mobile van duty vide Pradhan Nagar PS GDE No-194 Dated 04.04.2022 at around 10:25 hrs I along with C/1419 Ashis Roy and CV/1035 Sanjib Oraon had been to Deshbandhu hindi High School (H.S) and found that the above noted person opened his Xerox shop situated within 100 metre of the examination venue violating the Ld. Court Order dated 28.02.2022 issued by SDM Siliguri vide memo No 101(60)/Beng Dated 28.03.2022 . Accordingly, I order him to shut down his shop immediately but he did not pay any heed to my order. Hence, finding no any other alternative I arrested him following all formalities of arrest and seized one multifunction Printer machine bearing model No 2313C018, made in Vietnam SL No KMAG26803 under proper memo of seizure. The seizure was made in between 10:45 hrs to 10:55 hrs.

I, therefore, request you to kindly start a specific case against Saroj Manna (47) s/o Lt. Aditya Manna of Madhab Chowk, PS-Sabang, Dist- Paschim Midnapore under proper section of law and oblige.
