Sir,

In producing herewith two arrested accused persons namely (1) Ashish Praja @ Camron (27), S/O. Lt. RamuPraja of Sukna, Part No. 1, P.S. - Kurseong, Dist. - Darjeeling and (2) Arjun Chhetri (25) S/O. Nar Bahadur Chhetri of 4th Mile, P.S. - Kalimpong, Dist. - Kalimpong, A/P - Pati Colony, Gallu No. 2, P.S. - Pradhan Nagar, Dist. - Darjeeling under arrest along with the seized following articles: -

- i) 1(one) iron made improvised fire arms (Single Shooter) measuring about approx 9.4" (approx) inches in length including its butt, body and barrel in normal position with trigger and firing pin in working condition marked as Exhibit-"A" which is recovered from the waist of accused Ashish Praja @ Camron
- ii) 01(one) round live ammunition which was loaded in the improvised fire arms(marked as Ex- A) marked as "A-1".
- iii) 1(one) iron made improvised fire arms (Single Shooter) measuring about approx 8.9"(approx) inches in length including its butt, body and barrel in normal position with trigger and firing pin in working condition marked as Exhibit-"B" which is recovered from the waist accused Arjun Chhetri
- iv) 01(one) round live ammunition which was loaded in the improvised fire arms (marked as Ex- A) marked as "B-1".

I PSI Kalyan Saha of Pradhannagar PS under Siliguri Police Commissionerate would like to lodge this written complaint against (1) Ashish Praja @ Camron (27), S/O. Lt. RamuPraja of Sukna, Part No. 1, P.S. - Kurseong, Dist. - Darjeeling and (2) Arjun Chhetri (25) S/O. Nar Bahadur Chhetri of 4th Mile, P.S. - Kalimpong, Dist. - Kalimpong, A/P - Pati Colony, Gallu No. 2, P.S. - Pradhan Nagar, Dist. - Darjeeling to the effect that today i.e.on 04.04.2022 at 20.35 hrs. I received a source information that, two persons is seating on the Mahananda River Bed,near Parbati Ghat, Ward No. 45, Pradhan Naghar, Siliguri possessing illegal firearms with a view to commit heinous crime a in Siliguri area. Accordingly, the fact was diarized vide Pradhannagar PS GD Entry No. 245 date 04.04.2022 and I informed the fact to you. As per your direction myself along with PSI Sumit Sarkar, PSI Kamini Ray, ASI Nilam Swarnakar, CV-128 Ajoy Kumar Sahani, CV 242 Rakesh Mangar all of Pradhannagar PS immediately rushed to the spot with vehicle No WB 74AC-9851 to verify the veracity of the information.

On way, I called two witnesses namely (1) Suraj Routh S/o Ramavtar Routh, of Mahananda Colony, Ward No-1, PS - Pradhannagar Dist -Darjeeling and (2) Azad Khan s/o Lt. Abdul Rauf Khan of Biswas Colony PS Matigara,Dist -Darjeeling and narrated them the information in hand after disclosing our identity and requested them to accompany with us as witnesses. Accordingly, they had given their consent and become willing to accompany with us. We reached near the spot as identified by the source at about 21.10 hrs. and managed to apprehended the above noted persons. Then I searched their person as per

provision of law and on search I could recovered above noted Improvised firearms loaded with one round ammunition from the exclusive possession of arrested persons as mentioned above which he kept conceal position in the back side of his waist.

On interrogation they disclosed their name and identity as noted above. On demand they failed to produce any valid documents or license in support of possessing Fire Arms and ammunition. They also admitted that they have procured the fire arms and ammunition illegally from Bihar to commit crime against property with his associates. Accordingly, the above noted firearms and ammunitions have been seized in between 21.25Hrs to 22.15hrs under proper seizure list in presence of the witnesses duly signed by them and acknowledged by the apprehended persons. There after sealed and labeled the seized the articles. Then I arrested the above noted accused persons after communicating the ground of arrest and issued memo of arrest for violation of provisions of Arms Act.

Under the above circumstances, I pray before you that a specific case may kindly be started against the arrested accused person namely (1) Ashish Praja @ Camron (27), S/O. Lt. Ramu Praja of Sukna, Part No. 1, P.S. - Kurseong, Dist. - Darjeeling and (2) Arjun Chhetri (25) S/O. Nar Bahadur Chhetri of 4th Mile, P.S. - Kalimpong, Dist. - Kalimpong, A/P - Pati Colony, Gallu No. 2, P.S. - Pradhan Nagar, Dist. - Darjeeling under proper section of law and arrange for its investigation.
