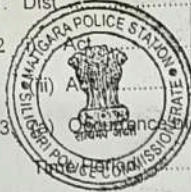

Sir,

In producing herewith one accused namely Raju Mandal (M/22) s/o Gouranga Mandal of Shaktigarh, Ward No. 31, Road No. 6, near Shaktigarh Girls School, PS- New Jalpaiguri, Dist- Jalpaiguri under arrest along with the seized article as per seizure list viz " One improvised fire Arm ( Revolver) made of Iron and wood clamped butt, consisting of barrel, trigger and ammunition chamber having total length of 10 " ( Diagonally), consisting barrel measuring 7.5" including Chamber for six ammunitions measuring 1.5" and butt clamped with wood measuring 2.5", loaded with 01 (one) live ammunition" (The above noted fire arm was concealed in the right back waist inside the pant of the accused)

I, SI Biswajit Ghosh O/C, NBMC OP under Matigara PS, SPC, do hereby lodge a written complaint against the above mentioned accused person to the effect that today on 04.04.2022 at 17.05 hrs I received source information that one unknown person is moving suspiciously in and around Chathat Medical More under Matigara PS jurisdiction. I diarised the matter vide NBMC & H OP GDE No. 100 Dtd. 04.04.2022 and I along with ASI Anupam Roy, Const. 402 Abhishek Gupta and CV-158 Partha Sarkar left to work out the veracity of the information. On reaching at Chathat Medical More, as indicated by source, we apprehended the suspect, disclosed our identity and the reason of apprehending him. On interrogation he disclosed his name and address as Raju Mandal (M/22) s/o Gouranga Mandal of Shaktigarh, Ward No. 31, Road No. 6, near Shaktigarh Girls School, PS- New Jalpaiguri, Dist- Jalpaiguri. I asked the suspect to search me in person in front of the witnesses before searching him, which he denied to do and I searched him in person in presence of the witnesses. During search, a fire arm as noted above, kept concealed on the right back waist inside his pant was recovered from his possession. During careful examination it was observed that the fire arm was loaded with one round of live ammunition. On demand he failed to produce any valid document in support of the possession of the fire arm and the ammunition. On interrogation, he confessed that he had procured the fire arm illegally. I seized & Labelled the above noted arm & ammunition under proper seizure list duly signed by the accused and witnesses. I also arrested the above mentioned accused u/s 41 Cr.PC. The seizure was made between 17.45 hrs and 18.55 hrs.

Hence, I pray that a specific case may kindly be started against the arrested accused person namely Raju Mandal (M/22) s/o Gouranga Mandal of Shaktigarh, Ward No. 31, Road No. 6, near Shaktigarh Girls School, PS- New Jalpaiguri, Dist- Jalpaiguri and others under proper section of law and arrange for its investigation.
