Sir,

In producing herewith one (01) arrested accused person namely Sonu Mohanta (28) S/O Lt. Kanu Mohanta of Biswas colony, P.O+P.S- Matigara, Dist.- Darjeeling (not verified) along with the following articles under seizure as per seizure list;

1. One iron made improvised one shutter Firearm having its trigger, hammer and firing pin measuring approx 9 inch including its butt, body and barrel loaded with one number of ammunition inscribed as "BMM" and "KF" and marked as "Exhibit-A".. [The articles have been found kept concealed on the left side of waist of accused Sonu Mohanta ]

I, SI Newton Biswas, S/O- Nirmal Biswas of Matigara Police Station, Siliguri Police Commissionerate do hereby lodge this written complaint against above noted one (01) arrested accused person namely Sonu Mohanta to the effect that today, on 04.04.2022 at about 21.10 hrs I received a specific source input that one person is standing near Webel IT Park, Shimultala under Matigara PS for committing heinous crime. He used to carry and possess small arms & ammunition with him. The matter was diarized vide Matigara PS GDE No. 197 Dt. 04.04.2022. Accordingly, I informed the matter to the Officer-in-Charge, Matigara Police Station. Subsequently, as per his kind direction myself along with ASI Nitai Mandal, C/1035 Santosh Rabidas and CV/378 Sukumar Barman all of Matigara PS and along with investigation kit left for near Webel IT Park, Shimultala under Matigara PS by govt. vehicle to verify the veracity of the information. Under this circumstance any search warrant or authorization cannot be obtained without affording opportunity for the concealment of evidence or facility for the escape of the offender.

On way to Webel IT Park, Shimultala under Matigara PS, I contacted two persons namely (i) Golak Barai S/O Bhim Barai of Shimultala, PO+PS Matigara, Dist Darjeeling and (ii) Md. Khalilur Rahaman S/O Lt. Hachan Ali of Tarijote, P.O- New Rangia, PS Matigara, Dist Darjeeling and make them aware of the information in hand and requested them to act as witness, if any search and seizure would be made necessary upon which they agreed.

Thereafter we along with the independent witnesses reached at near Webel IT Park, Shimultala under Matigara PS at 21.35 hrs and being pointed by my source apprehended the above noted accused person named Sonu Mohanta and searched him immediately and found the above noted articles from his exclusive and conscious possession. On demand he failed to produce any document in support of his possessing and carrying of such type of fire arms and ammunition. Hence, it is evident that the accused named Sonu Mohanta exclusively & consciously possessed this improvised fire arms loaded with live ammunition illegally with some ill motives.

Thus, his involvement in carrying and possessing illegal fire arm is established. Accordingly, I seized and labeled the above noted articles at the spot under proper seizure list duly signed by him as well as by the above noted independent witnesses and also put their signature on the seizure list and label. The seizure has been done in between 22.05 hrs to 22.35 Hrs. I also arrested him preparing memo of arrest after informing ground of his arrest.

From the above noted facts and seizure of incriminating articles there is strong reason to believe that the accused Sonu Mohanta has carried the said fire arms loaded with live ammunition with an objective to commit **heinous crime in the locality.**

Under the above circumstances, I pray to you that a specific case under proper section of law may kindly be started against the accused person namely Sonu Mohanta (28) S/O Lt. Kanu Mohanta of Biswas colony, P.O+P.S- Matigara, Dist.- Darjeeling (not verified) and arrange for its investigation.
