

That during the first three months of his employment, his conduct was satisfactory but only after working for three (3) months, after receiving the salary for the month of December, he demanded an increase in pay scale which was more than double the amount of his monthly salary i.e., a sum of Rs. 35,000/- (Thirty-five Thousand) per month, which I could not afford to pay him and which I peacefully denied to him. After the aforesaid denial on salary increase, he became indescient in his attitude and started misbehaving with me, my husband Ravi Pareek and our other employees on a frequent basis.

Due to his consistent indescient behavior, on 19.02.2022, I asked him to leave the work on which he did not agree and replied that he possesses good relation with influential people of the city. After listening which, I fired him from the job and all his dues were cleared in the due course of time.

Shockingly, on 22.02.2022, my husband, Ravi Pareek got a phone call from Rohit Prasad, who blackmailed us that he has information of all the confidential and sensitive documents and information of our company to which the company never gave access to him and demanded from us a sum of Rs. 7,00,000 (Rupees Seven Lakhs). He repeatedly makes threatening phone calls and mentally torture us that he is an Advocate having power and money and if we do not fulfil his unlawful demands, he will go to any extent to finish my life and property.

Today at around 2 p.m. when I was at my workplace alongwith Navin Changia (employee) and my husband Ravi Pareek, Rohit Prasad kicked the entrance door of 'M/s Vogatt Univera' and entered the premises, abused me and other persons in filthy languages and slangs and when I screamed for help he grabbed my neck and slapped me multiple times.

When my husband Ravi Pareek and Navin Changia came forward in my self defence, Rohit Prasad started hitting them with fist and blows and kicking us several times entire over the body. Somehow, we managed to rescue ourselves from his attacks.

It is pertinent to mention here that Rohit Prasad is a habitual offender and is connected with these kinds of activities of extorting money from innocent men and often seen with anti-social muscle men.

I request your esteemed office to take strong and deterrent action against Rohit Prasad and book him against relevant penal sections as per the law of the land.


