Respected Sir,

I SI (UB) Amir Kumar Singh of Jalpaimore Traffic Guard, SPC lick to lodge this complaint against one TOTO (E Rickshaw) driver namely Sikendar Sahani (35 yrs), S/O- Upendra Sahani of Santoshi Nagar, Jora Bridge, Ward No-05, PS- Siliguri, Dist- Darjeeling to the effect that, on 04.04.2022 at about 14.10 hrs during my M/C Mobile duty at Santoshi Nagar More under Siliguri PS, I found that the said Toto driver who disclosed his name & identity as noted above proceeded towards Jhankar More side from Santoshi Nagar side loaded with 10 (ten) pieces of M.S. angels and M.S wire Rod in dangerous manner with high possibility of fatal accident as the length of the Toto (E Rickshaw) is almost three times less than the length of the loaded goods violating Govt. Order and obstructing public way at Burdwan Road. I along with my accompanied CV/167 Tanay Banerjee stop him. On being demand, the above noted driver of the TOTO failed to produce any valid documents or papers of the said M.S. angels and M.S wire Rods. Accordingly, I seize the above noted articles and TOTO (without number plate) under proper seizure list and arrested the driver of the TOTO named Sikendar Sahani (35 yrs), S/O- Upendra Sahani of Santoshi Nagar, Jora Bridge, Ward No-05, PS- Siliguri Dist- Darjeeling u/s- 41 Cr.P.C

Hence, I would, therefore request you to kindly start a specific case U/S- 188/283 IPC against the above noted arrested accused person and arrange for its investigate of the case.
