Sir,

With due respect, I Sri Ashok Bansal S/o Late Narsingh Das Bansal, resident of Sukanta Sarani, Milanpally, Near Netaji School, P.O & P.S - Siliguri, District - Darjeeling would like to inform you that on 1 - 4 - 2022 at about 9 p.m. my son Kunal Bansal S/o Ashok Bansal aged about 31 hanged himself to die at my residence resulting he expired. Prior to his hanging he left a suicide note. It is to be mention here that on 25 - 2 - 2020 the marriage of my son was solemnized with one Smt. Sweety Agarwal, D/o Meghraj Agarwal of C/o Swastik Plywood Centre, 2<sup>nd</sup> Mile, P.C. Mittal Bus Stand, P.O.-Sevoke Road, P.S - Bhaktinagar, District Jalpaiguri, and soon after marriage, his wife has started unusual and abnormal behaviour with him and used to picking up hue and cry and has started levelling false allegation against him without any authentic reasons and out of anger she off and on started torturing him physically and mentally.

Due to inhuman torture from the part of the said Smt. Sweety Agarwal, on 5-5-2021, my son separated his mess and residence with my other family members and started residing in a rented house at Bhugat Niwas, S.P. Mukherjee Road, Khalpara Siliguri to make his wife happy but inspite of having separate mess and residence, his wife is not being satisfied with him and has started involving her parents and brother in her personal matter causing her father Sri Meghraj Agarwal, her brother namely Piyush Agarwal have started torturing my son even her father has also slapped him in the month of October 2021. Sweety Agarwal, Sri Meghraj Agarwal and Piyush Agarwal off and on used to induce him to commit suicide to make her free from the marital relation in default she herself commit suicide to involve him in false case not only that her father also used to threat him to kill him and will involve him in criminal case. On 28 - 9 - 2021 my son also lodged complaint before Police Commissioner stating enter-alia but with no result. Sweety Agarwal her father Meghraj Agarwal and her brother Piyush Agarwal have made his life hell and they always curse him for his death and since the day of marriage they were torturing him, with threatening and abusing him in filthy languages to make his life hell.

Lastly, when the mental torture became unbearable for my son, he committed suicide.

My son has ended his life due to continuous inducement from the end of his wife, father in law, and brother in law as above named. On 2 - 4 - 2022 the post-mortem was conducted and due to such incident, and loss of life of my son, I could not lodge my FIR immediately.

So, requesting you to investigate the matter and take necessary legal actions against the said Smt. Sweety Agarwal her father Meghraj Agarwal and her brother Sri Piyush Agarwal who are the abettor to death of my son, for the interest of justice for which I will highly oblige to you.
