Sir,

In producing herewith one arrested person who disclosed his identities namely Biki Balmiki (26 yrs) S/O Hansingh Balmiki of Tikiapara, Ahmedkar Colony, Ward No. 28, PS- Siliguri, Dist- Darjeeling along with the seized articles per seizure list;

1. One improvised one shutter iron made fire arms measuring approx 10.00 inches from barrel to wooden butt having striking pin, hammer and trigger marked as Exhibits- A
2. One ammunition engraved O.K BK 7 unreadable on its percussion cap (found loaded in SI No.1 seized exclusively from possession of accused Biki Balmiki marked as Exhibits-A1

I, Uday Chakraborty of Siliguri Police Station, Siliguri Police Commissionerate do hereby lodge this complaint against Biki Balmiki (26 yrs) S/O Hansingh Balmiki of Tikiapara, Ahmedkar Colony, Ward No. 28, PS- Siliguri, Dist- Darjeeling that on 04.04.22 around 20.50 hrs, received a secret source information that one veteran criminal namely Biki Balmiki of Tikiapara is roaming at Tikiapara more area under Siliguri PS with an ulterior motive and is in possession of firearms. Dairsed the mater vide Siliguri PS GD Entry No. 257 dated 04.04.22. As per your kind instruction of I/C Siliguri PS, I along with ASI Subir Sen, ASI Dhruva Misra, ASI Siben Sarkar, CV/622 Ramanath Barman, CV/283 Prosenjit Dey all Siliguri PS rushed to the place at Tikiapara more area to verify the veracity of this information vide Siliguri PS G.D.E no. 258 dated 04.04.22. On way I picked up two disinterested witnesses namely (i) Md Sarafat (20 yrs) S/O Idrish Master of Tikiapara, Mazdoor Colony, Ward No. 28, PS- Siliguri, Dist- Darjeeling and (ii) Manjit Singh (30 yrs) S/O Sri Ranjit Singh of Kawakhali, Medical, PS- Matigara, Dist- Darjeeling duly informing them about the information in hand. At 21.05 hrs we reached at nearby Tikiapara more and as per description of the wearing apparels supplied by the source, we found that the above noted person is moving suspiciously at Tikiapara more area. On seeing the police party he tried to escape from the place. But we apprehended the above noted person namely Biki Balmiki. On being asked, the apprehended person disclosed his identity as noted above. On further interrogation he admitted that he was in the Tikiapara more with an ulterior motive. Accordingly, as per information and following all necessary procedures of search of the police person by the witnesses, search of the apprehended person Biki Balmiki was made on search and found that One improvised one shutter iron made fire arms measuring approx 10.00 inches from barrel to wooden butt having striking pin, hammer and trigger along with one ammunition engraved O.K BK 7 unreadable on its percussion cap marked as Exhibits- A was recovered from his exclusively possession, which was kept concealed under the Track trouser on the left side of the above noted accused person's waist. The ammunition was unloaded from the firearms as per practical experience. On being asked about the possession of the firearms and ammunition, the apprehended Biki Balmiki made incoherent statements and failed to produce any valid documents in support of said seized Firearms. As there is every reason to believe that the firearms and ammunitions recovered has been procured dishonestly by the apprehended Biki Balmiki for his ulterior motive, seized and labelled the firearms and ammunition duly taking its measurements and details in presence of the witnesses duly signed by them and acknowledge by the apprehended person and arrested him following all formalities. seizure and label was made in-between 21.10 hrs and 22.00 hrs. On being further asked the arrested accused person admitted that he was present at Tikiapara more being armed with Fire Arms with an ulterior motive.

Under the above circumstances, I pray that a specific case under Arms Act may kindly be started against the arrested Biki Balmiki (26 yrs) S/O Hansingh Balmiki of Tikiapara, Ahmedkar Colony, Ward No. 28, PS- Siliguri, Dist- Darjeeling and arrange for its investigation.
