Sir,

I, SI Uday Chakraborty of Siliguri P.S. Siliguri Police Commissionerate, do hereby lodged this written complaint against the arrested accused persons namely; (1) Md. Ali (22 yrs) S/O Nur Mohammad of Tikiapara, Hatath Colony, Ward No. 28 PS- Siliguri, Dist- Darjeeling, (2) Pradip Das @ Poltu (23 yrs) S/O Late Manik Das of Tikiapara, Matangini Colony-II, Ward No. 28, PS- Siliguri, Dist- Darjeeling, (3) Tapash Mahanta (24 yrs) S/O Late Ram Mahanta of Durga Das Colony, Ward No. 20, PS- Siliguri, Dist- Darjeeling (4) Sonu Subba @ Kancha (22 yrs) S/O Late Som Subba of Tindhariya, Chunavati near Child Park, PS- Kurseong, Dist- Darjeeling, A/P Coal Depot, Ward No. 07, PS- Siliguri, Dist- Darjeeling under arrest along with following seizure articles; (i) One (01) knife measuring approx. 12" including handle recovered from the possession of Md. Ali (knife was on his hand) (ii) One iron rod measuring approx. 28" pointed at one end (seemed to be implement of house breaking) recovered from Pradip Das @ Poltu (iii) One Knife (Sharp Cutting weapon) measuring approx. 12" including its handle recovered from the possession of Tapash Mahanta, which he was holding on his hand, (iv) One house breaking Iron Rod measuring approx 18 "including handle recovered from the possession of Sonu Subba @ Kancha.

In this regard, I beg to report that on 05.04.22 at 01:35 hrs received secret reliable source information that about 14/16 anti socials being armed with deadly weapons assembled at Rathkhola maidan under Siliguri PS for making preparation to commit dacoity at Rathkhola area. I informed this source information to IC Siliguri PS and noted the information vide Siliguri PS GDE No. 275, Dated. 05.04.22. As per the direction of IC Siliguri PS, at 01.45 hrs, I along with SI Diptajit Dhar, ASI Subir Sen, ASI Siben Sarkar, ASI Dhruva Mishra, C/1192 Nepal Barman CV/283 Prosenjit Dey, CV-622 Ramanath Barman left for Rathkhola maidan Bharat under Siliguri PS for working out the information vide Siliguri GDE No. 276, dated 05.04.22 after briefing officers and force properly and also along with required papers / articles. At 01.55 around hrs we reached at near Rathkhola maidan under Siliguri PS and kept our vehicle at considerable distance near Rathkhola maidan. Then, I along with Officers and force headed towards Rathkhla maidan under Siliguri PS looking for witnesses, if any on the way and found nothing. By this time we reached at Rathkhola maidan under Siliguri PS, as informed by secret source, we could see a group of persons standing and were whispering in subdued suspicious manner. On seeing us, they tried to flee away but somehow, above noted four persons could be apprehended and detained them. Then, after disclosing our identity, I asked them their motive to assemble at such a place and in such odd hours of night and in such a suspicious manner. On being asked they disclosed their names and

address as noted above and admitted that they along with 10/12 others assembled at the spot making preparation to commit dacoity tonight at Rathkhola area. I accordingly searched them in presence of witnesses and found ; (i) One (01) knife measuring approx. 12" including handle recovered from the possession of Md. Ali (knife was on his hand) (ii) One iron rod measuring approx. 28" pointed at one end (seemed to be implement of house breaking) recovered from Pradip Das @ Poltu (iii) One Knife (Sharp Cutting weapon) measuring approx. 12" including its handle recovered from the possession of Tapash Mahanta, which he was holding on his hand, (iv) One house breaking Iron Rod measuring approx 18 "including handle recovered from the possession of Sonu Subba @ Kancha were making preparation for committing Dacoity tonight in Rathkhola area but others managed to escape from the spot. Accordingly, I seized above noted weapons in presence of above mentioned witnesses under proper seizure list duly signed by them and labeled the same and arrested them informing them their ground of arrest preparing memo of arrest. The seizure and label was made in between 02.45 hrs to 04.25 hrs dated 05.04.2022. On further interrogation the arrested accused persons also confessed that they along with others assembled at the spot for making preparation to commit Dacoity tonight in Rathkhola area, but others managed to escape from the spot.

From the above noted facts, seizure and circumstance there is reason to believe that accused persons had assembled there with deadly weapons making preparation to commit dacoity at Rathkhola area.

Further, it to mention here that the arrested accused persons are well known anti social and have been indulged in many criminal cases.

Therefore, I pray before you to start a specific case against the above noted arrested accused persons & others 10/12 others who fled away, under proper section of law and to cause its investigation.
