I, Rajib Mahato (32) s/o Sri Satish Mahato, resident of Santoshi Nigam (Near Khetri Shyam Mandir, ward No. 5 SMC, PO & P.S. Siliguri, Distt - Dujeeley, beg to inform you that on dt. 03-04-2022 at abt 12:30 pm in the afternoon, when I was getting returning home and reached near Mackellmore, Santoshi Nigam, at that time, one Umesh Mahato s/o late Haneram Mahato @ Gopal, of Santoshi Nigam (Near Khetri Shyam Mandir, ward No. 5 SMC, PO & P.S. Siliguri, Distt - Dujeeley, started abusing me in filthy languages and when I protested he picked up a bi-cycle from nearby cycle repair shop of Manggi Mandir and bashed it on my head with bicycle and I received severe injury in my head & person and immediately shifted to Arogya Niketan, Nursing Home Khalpara, and admitted there.

I discharged from Arogya Niketan, Nursing Home today, and lodging two complain.

Sir, the above noted alleged persons are very desperate & dangerous in whom and he has threatened me for dire consequences.

So, please take necessary action against said Umesh Mahato (22) s/o Lt. Haneram Mahato @ Gopal, resident of Santoshi Nigam (Near Khetri Shyam Mandir), ward No. 5 SMC, PO - Siliguri Nigam, P.S. - Siliguri, Distt - Dujeeley.
