Sir,

In producing herewith one arrested accused person namely Jinnat Ali (52) S/o Lt. Hafijuddin Md. of Veshpara, Akariganch PS-NJP, Dist-Jalpaiguri who has been arrested u/s- 41 Cr.P.C along with the following seized articles viz-

One (01) single-shatter iron made fire-arms having length about 47 cm with body, trigger, firing pin, barrel and wood-fitted butt marked as Exhibit -A.

I, ASI Md. Jamirul Haque of Ambari-Falakata Out Post, Ps-NJP, SPC, do hereby submit this written complaint against the above noted accused person to the effect that, on 04.04.2022 during my mobile van patrolling duty, I have received a specific reliable source information that, one person is loitering with illegal arms which is concealed in his person near Veshpara, Akariganch. Therefore, I conveyed the same to O/C, Ambari-Falakata OP and as per his direction I along with mobile van force C/625 Bhabendra Das & C/393 Shyamal Roy all of Ambari-falakata OP, Ps-NJP, SPC left for Veshpara, Akariganch to verify the veracity of the information. At about 19.15 hrs we have reached near Veshpara, Akariganch and meanwhile called one independent witnesses and disclosed our identity and informed him about the information and requested him to accompany us in the whole process during search and seizure, if any. Being accompanied by source and the witness our whole police party started keeping watch over people near Veshpara, Akariganch. At around 19.45 hrs on being identified by the source we have apprehended one suspected person who, during interrogation, disclosed his name & identity as noted above.

Therefore, I have searched the above noted suspected person in presence of the said witness and recovered one fire arms from the possession of Jinnat Ali which was kept concealed in his right waist. On being asked he failed to produce any valid license in respect of possession of such gun. On being demand he failed to justify for carrying the said Fire Arms. On further interrogation he stated that he had procured the said fire arms illegally with intend to sale for his wrongful gain. His movement was suspicious and he could not able to even clarify his alibi and status why he is moving in this area. Myself with the help of my team and in presence of local witness searched him but found nothing except fire Arms.

Accordingly, I seized One (01) single-shatter iron made fire-arms having length about 47 cm with body, trigger, firing pin, barrel and wood-fitted butt and marked as Exhibit -A through proper seizure list, duly signed by the witnesses and accused person and packed, labelled, & sealed the arms on the spot. The seizure & label was made in between 20.15 Hrs to 20.55 Hrs. dated 04.04.2022. Then, I arrested him after observing all formalities u/s 41A of CrPC and issued memo of arrest accordingly.

Therefore, I pray before you to start a specific case against the above noted accused person namely Jinnat Ali (52) S/o Lt. Hafijuddin Md. of Veshpara, Akariganch PS-NJP, Dist-Jalpaiguri under proper section of law and to cause its investigation.
